I. OPENING OF MEETING 11:00 A.M.— at 160 N. LaSalle Street, 4th Floor, Room S401, Chicago, IL

II. PRESENT

Pursuant to Section 7(a) of the Open Meetings Act, 5 ILCS 120/7(a), Board Member Keith Snyder, with the approval of a majority of the Board, participated via telephone conference call due to illness.

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD February 6, 2018

Chairman Hartnett called for approval of the minutes of the February 6, 2018 meeting. Member Coli moved to approve the minutes. Member Samolis seconded. The Board passed the motion unanimously, by a voice vote.
