III. APPROVAL OF MINUTES OF REGULAR MEETING HELD July 10, 2018

General Counsel Kim asked Associate General Counsel Anna Hamburg-Gal to call and present the issues of the case to the Board. After discussion, Member Samolis moved to accept the Executive Director dismissal. Member Glynn seconded the motion, and the Board passed it unanimously, by a voice vote.
