I. OPENING OF MEETING 11:00 A.M.— by video conference at 160 N. LaSalle Street, Room S-1316, Chicago, IL and EPA, 1021 North Grand Ave East, 2nd Floor, Springfield, IL

II. PRESENT

John Samolis, Member of the Board; Christopher Glynn, Member of the Board; Anna Hamburg-Gal, Associate General Counsel; and staff members participated via video conference from the Chicago location.

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD October 16, 2018

Chairman Hartnett called for approval of the minutes of the October 16, 2018 meeting. Member Samolis moved to approve the minutes. Member Glynn seconded. The Board passed the motion unanimously, by a voice vote.

IV. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

1. Case No. S-RC-17-003

Int'l Association of Firefighters, Local 2391, AFL-CIO, CLC and Village of River Forest

General Counsel Kim called the case. Member Samolis made a motion to approve the proposed written decision. Member Snyder seconded the motion, and the Board passed it unanimously, by a voice vote.

2. Case No. S-UC-17-067

State of Illinois, Department of Central Management Services and American Federation of State, County and Municipal Employees, Council 31

General Counsel Kim called the case. Member Samolis made a motion to approve the proposed written decision. Member Samolis seconded the motion, and the Board passed it unanimously, by a voice vote.

V. BOARD ACTIONS

1. Case No. S-CA-15-028

Nassor Zarif and Chief Judge of the Circuit Court of Cook County (Cook County Juvenile Temporary Detention Center)

General Counsel Kim called the case and noted that no party filed exceptions to the Administrative Law Judge's Recommended Decision and Order. The Board declined to review the decision on its own motion.

2. Case No. S-CA-18-056

American Federation of State, County and Municipal Employees, Council 31 and Chief Judge of the Circuit Court of Cook County

General Counsel Kim called the case and noted that no party filed exceptions to the Administrative Law Judge's Recommended Decision and Order. The Board declined to review the decision on its own motion.

3. **Case No. S-RC-18-026**
Village of Mundelein and Int'l Association of Firefighters, Local 4786, Mundelein Professional Fire Fighters

General Counsel Kim called the case and noted that no party filed exceptions to the Administrative Law Judge's Recommended Decision and Order. The Board declined to review the decision on its own motion.

4. **Case No. S-UC-17-083**
State of Illinois, Department of Central Management Services and American Federation of State, County and Municipal Employees, Council 31

General Counsel Kim called the case to the Board noting that the Union filed a Motion to Stay. After discussion, Member Snyder moved to deny the Motion. Member Samolis seconded the motion, and the Board passed it unanimously, by a voice vote.

5. **Case No. S-CA-18-085**
Policemen's Benevolent Labor Committee and City of Sparta

General Counsel Kim called the case to the Board noting that the Respondent filed a Motion for Sanctions. After discussion, Member Snyder moved to deny the Motion. Member Samolis seconded the motion, and the Board passed it unanimously, by a voice vote.
