



# 2021 Schedule 1299-D Instructions

## General Information

Complete this schedule if you are filing Form IL-1120, Corporation Income and Replacement Tax Return, Form IL-1041, Fiduciary Income and Replacement Tax Return, or Form IL-990-T, Exempt Organization Income and Replacement Tax Return, and are entitled to any of the credits listed on Schedule 1299-I, Income Tax Credits Information and Worksheets.

**This schedule must be completed if you earned credits this year; even if you are not using the credits to offset current tax liability.**

If you receive more than one of the same eligible credit code with the same expiration date, you should add all amounts for that credit code and enter the total on the corresponding line on Schedule 1299-D, Step 3, Column F.

If you are filing an Illinois **combined unitary** return, complete one Illinois Schedule 1299-D for the entire group. For each credit, you will need to complete at least one row on Schedule 1299-D, Step 3 for each unitary group member who received the credit.

*For example, unitary group member A (FEIN 12-3456789) earned \$300 of Film Production Services credit during the tax year ending 12/31/21. Member B (FEIN 98-7654321) earned \$400 of Film Production Services credit during the year ending 12/31/21. Complete Schedule 1299-D, Step 23 as follows:*

- enter "2026-12" in Column A, "5000" in Column B, "2021-12" in Column C, "12-3456789" in Column D, and "300" in Columns F and I
- enter "2026-12" in Column A, "5000" in Column B, "2021-12" in Column C, "98-7654321" in Column D, and "400" in Columns F and I

## What must I attach?

You must attach:

- Schedule(s) K-1-P, Partner's or Shareholder's Share of Income, Deductions, Credits, and Recapture, received from a partnership or S corporation.
- Certificates issued by the Department of Commerce and Economic Opportunity (DCEO)
- Certificates issued by the Illinois Department of Natural Resources (DNR)-
- Any other documents, including transfer documentation, required by the Illinois Department of Revenue (IDOR) and noted in these instructions or Schedule 1299-I.

**Note:** Specific information about what to attach to your Schedule 1299-D can be found in Schedule 1299-I.

Failure to follow these instructions and attach required documentation will result in one or more of the following: a delay in the processing of your return, the disallowance of the credit, or the issuance of correspondence from IDOR. You also may be required to submit further information to support your filing.

## Should I round?

You must round the dollar amounts on Schedule 1299-D to whole-dollar amounts. To do this, you should drop any amount less than 50 cents and increase any amount of 50 cents or more to the next higher dollar.

## Specific Instructions

In order to claim amounts reported to you on an Illinois Schedule K-1-P, the tax year ending listed on the Illinois Schedule K-1-P you received must fall within your tax year.

### STEP 1 - Worksheet

Complete this step only if you earned the Research and Development income tax credit during your current tax year.

#### Research and Development

Complete this step before entering any Research and Development credit earned in the current year in Step 3.

Complete the Research and Development Worksheet in Schedule 1299-I. Bring the corresponding amounts from Schedule 1299-I, Worksheet, Line 6, Columns A and B, to Schedule 1299-D, Step 1, Line 1, Columns A and B. Follow the instructions on Schedule 1299-D to calculate the amount to list in Step 3, Column F on the line that you enter Credit Code 5340 in Column B.

**STEP 2 - Calculate your credit for the current year**  
**\*\*Complete Step 3 before completing this Step\*\***

**Line 4 -**

Enter the total amount (sum) of credit available to be carried into this tax year from your 2020 Schedule 1299-D, Credit Carryforward to Next Year Calculation Worksheet, or other worksheet used to calculate your carry forward from 2020.

**Lines 5 through 10 -**

Follow the instructions on the form.

**STEP 3 - Enter your current credits**

**\*\*Complete this Step before completing Step 2\*\***

You must list **all** new credits, distributive shares, or transferred credits that were earned or received this year. This schedule must be completed if you earned or received credits this year, even if you are not using the credits to offset current tax liability.

If you have more qualifying credits than space provided on Schedule 1299-D, attach additional Schedule(s) 1299-D and enter the total credit you may claim on your original Schedule 1299-D, Step 2, Line 5 and Step 3, Line 35, Column I. **Do not enter the total on your additional schedules.**

Additionally, if you received more than one Schedule K-1-P for any eligible credit, add the amounts from all Schedules K-1-P for that credit and enter the total in Step 3, Column G on the line with that credit code on your Schedule 1299-D.

Follow the instructions below to complete Schedule 1299-D, Step 3, Columns A through E and Columns G through I. To determine the correct amount to list in Schedule 1299-D, Step 3, Column F, use the instructions in Schedule 1299-I, Income Tax Credits Information and Worksheets.

**Lines 11 through 34 -**

**Column A - Expiration Date**

Enter the four-digit year and two-digit month of the expiration of each credit. Separate the year and the month with a dash (YYYY-MM). For example, if you first earned and received a Department of Commerce and Economic Opportunity (DCEO) certificate for a Film Production Services credit in August of 2021 and you are a calendar-year filer, you will enter "2026-12" as the expiration date in Column A for this credit.

**Note:** Only credits earned this year are to be entered on this schedule.

**Column B - Credit Code**

Each credit has a four-digit code used to identify it. The first digit of the code indicates how many years the credit can be carried forward. For example, all credits that can be carried forward two years start with "2". The remaining three digits are the unique indicator for that specific code. Ten year carry forwards will use two digits for the year and two digits as the unique indicator. Credit codes that start with "0" cannot be carried forward.

**Expired Credits, can only be carried forward**

5390	Veterans Jobs (Credit earned in tax years beginning before January 1, 2015, for qualified veterans, and for tax years ending on or before December 31, 2016, for qualified unemployed veterans) <b>Credit may not be used on returns for tax periods ending after December 31, 2021.</b>
5530	River Edge Redevelopment Zone Investment (Credit earned in tax years beginning before July 12, 2016) <b>Credit may not be used on returns for tax periods beginning on or after July 12, 2021.</b>
5550	River Edge Redevelopment Zone Remediation (Credit earned in tax years beginning before July 12, 2016) <b>Credit may not be used on returns for tax periods beginning on or after July 12, 2021.</b>
5700	Natural Disaster (Credit earned in tax years beginning on or after January 1, 2017 and beginning prior to January 1, 2019) <b>Credit may not be used on returns for tax periods beginning after December 31, 2023.</b>
1000	Historic Preservation (Credit earned in tax years ending on or before December 31, 2015) <b>Credit may not be transferred, carried forward, or distributed on returns for tax periods ending after December 31, 2025.</b>

**Column C - Credit Earned**

Write the four-digit year and two-digit month of the Illinois tax year ending during which the credit was first earned. Separate the year and the month with a dash (YYYY-MM). For example, if you first earned and received a Department of Commerce and Economic Opportunity (DCEO) certificate for a Film Production Services credit in August of 2021 and you are a fiscal filer with a tax year beginning July 1, 2021 and ending June 30, 2022, you will enter "2022-06" for this credit.

**Note:**

- If you are a 52/53-week filer, use the calendar or fiscal year-end date closest to your tax year-end date. For example, if a 52/53-week filer has a year ending of 12/27/2021 or 1/2/2022, they would use 2021-12 for their tax year end date.

- If you are filing a short year return, use the last month that your tax year-end falls in to determine your Tax Year Credit Earned. For example, a short year return filed for the period of 1/1/2022 - 2/15/2022 would use a tax year end date of 2022-02.

### Column D - Unitary Member FEIN

Enter the FEIN of the unitary member that earned the credit. If you are non-unitary filer, this column should be left blank.

### Column E - Certificate Number

If you **earn** the Invest in Kids credit, enter the certificate number from the Certificate of Receipt (COR) you received from the Scholarship Granting Organization (SGO).

If you receive a **distributive share** of the Invest in Kids credit, do not enter anything in Column E.

For all other credits leave this column blank.

### Column F - Credit Amount Earned

Use the instructions and worksheets in Schedule 1299-I to determine the correct amount of credit to report in this column.

**Keep a copy of Schedules 1299-I and 1299-D in your records. You may be asked to provide a copy of Schedule 1299-I as additional verification and you will use these schedules to complete your credit carryforward information on Schedule 1299-D next year.**

### Column G - Distributive Share Credit from K-1-P

Enter the sum of your distributive share of credits that were received from an S corporation or partnership on Schedule K-1-P.

In order to claim the amount reported to you on a Schedule K-1-P, the tax year ending listed on a Schedule K-1-P you received must fall within your tax year. If you report an amount in this column, include a copy of the Schedule(s) K-1-P you received.

For non-unitary filers, if you receive more than one Schedule K-1-P with a distributive share of the same eligible credit, you should add the amounts from all Schedules K-1-P for that credit and enter the total on the corresponding line on Schedule 1299-D, Step 3, Column G.

If you are a unitary group and you are claiming distributive shares received by multiple unitary group members, complete a separate row on Schedule 1299-D, Step 3 for each credit type and each unitary group member that received the distributive shares. On each row, list the FEIN of the member that received the distributive share in Column D.

*For example, unitary group member A (FEIN 12-3456789) received \$500 in distributive shares for the Angel Investment credit during the tax year ending 12/31/21. Member B (FEIN 98-7654321) received \$300 in distributive shares for the Angel Investment credit during the tax year ending 12/31/21. Member C (FEIN 99-1188227) received \$300 in distributive shares for the Film Production Services credit on one Schedule K-1-P and \$250 in distributive shares for the Film Production Services credit on another Schedule K-1-P, during the tax year ending 12/31/21. Complete Schedule 1299-D, Step 3 as follows:*

- enter "2026-12" in Column A, "5000" in Column B, "2021-12" in Column C, "99-1188227" in Column D, and "550" in Columns G and I
- enter "2026-12" in Column A, "5460" in Column B, "2021-12" in Column C, "12-3456789" in Column D, and "500" in Columns G and I
- enter "2026-12" in Column A, "5460" in Column B, "2021-12" in Column C, "98-7654321" in Column D, and "300" in Columns G and I

See Example 2 on Page 3.

**Note:** In this example, you will need to attach **both** Schedules K-1-P from Member C, as well as the Schedules K-1-P from Members A and B.

Amounts in this column should only contain Distributive Shares of Credit reported on Schedule K-1-P received in the current tax year.

**Note:** List **your** tax year ending as YYYY-MM in Column C. **Do not** list the tax year ending from Schedules K-1-P.

### Column H - Transferred Credit Amount

Enter the amount of any credit transferred to you.

If you report an amount in this column, include:

- a copy of the written notice of the transfer that the seller or donor received from the Department of Commerce and Economic Opportunity or Department of Natural Resources, or
- a copy of the written notice of the transfer that the seller or donor sent to IDOR.

If you are a non-unitary filer and you receive more than one transfer of the same eligible credit code with the same expiration date, you should add the amounts from all transfers for that credit code and enter the total on the corresponding line on Schedule 1299-D, Step 3, Column H.

If you are a unitary group and you are claiming credit transfers received by multiple unitary group members, complete a separate row on Schedule 1299-D, Step 3 for each credit type and each unitary group member that received the transfer. On each row, list that member's FEIN in Column D, and enter the total sum of all transfers that member received for the specific credit identified in Column G.

*For example, unitary group member A (FEIN 12-3456789) received a transfer of \$8,000 of the Affordable Housing Donations credit with an expiration date of 12/31/2022 during the tax year ending 12/31/21. Member B (FEIN 98-7654321) received a transfer of \$3,500 of the Film Production Services credit with an expiration date of 12/31/2026 and a transfer of \$11,000 of the Hospital credit with an expiration date of 12/31/2026 during the tax year ending 12/31/21. Member C (FEIN 99-1188227) received two transfers with the same expiration date (12/31/2026) from different entities of the Hospital credit, one for \$30,000 and one for \$15,000 during the tax year ending 12/31/21. Complete Schedule 1299-D, Step 3 as follows:*

- enter "2022-12" in Column A, "5260" in Column B, "2021-12" in Column C, "12-3456789" in Column D, and "\$8,000" in Columns H and I

- enter "2026-12" in Column A, "5000" in Column B, "2021-12" in Column C, "98-7654321" in Column D, and "\$3,500" in Columns H and I
- enter "2026-12" in Column A, "5620" in Column B, "2021-12" in Column C, "98-7654321" in Column D, and "\$11,000" in Columns H and I
- enter "2026-12" in Column A, "5620" in Column B, "2021-12" in Column C, "99-1188227" in Column D, and "\$45,000" in Columns H and I

### Column I - Total Credit

Total the amounts in Columns F, G, and H for each row and enter the result here.

### Line 35 -

Total Column I and enter the amount here and in Step 2, Line 5.

**Keep a copy of Schedule 1299-D for your records and for use next year.**

## Credit Carryforward Calculation

Use the Credit Carryforward to Next Year Calculation Worksheet and Instructions on Pages 5 and 6 to calculate your credit carryforward to next year. If you already have a method of tracking your credit carryforward, you do not need to complete these pages.

**Note: Do not** send these pages with your return.

# Credit Carryforward to Next Year Calculation Worksheet Instructions

If you do **not** have a tracking system for your credits, use your prior year Credit Carryforward to Next Year Calculation Worksheet (Worksheet) and current year Schedule 1299-D, Step 3 to complete the current year Credit Carryforward to Next Year Calculation Worksheet.

## Column A - Expiration Date

**1. Figure the expiration date** - Use the information in your prior year Worksheet, Column A, and your current year Schedule 1299-D, Step 3, Column A, to determine the expiration date of your credits.

**2. Enter credits in the following order** - Using the prior year Worksheet and current year Schedule 1299-D, enter credits with the earliest expiration date first. Then list the next earliest date and progress chronologically until all available credit has been listed. Do not include credits from your prior year Worksheet that list an Expiration Date in Column A that is prior to your current Tax Year End. Do not include credits from your prior year Worksheet that list zero in Column F, Credit Carryforward to Next Year. If you have multiple credits with the same expiration date, list them in ascending order by credit code within the zero-year, then two-year, then five-year and finally ten-year credits. Applying the credits in this manner ensures that the credits are used in the correct order. Credits are applied based on the earliest expiration.

## Column B - Credit Code

Enter the Credit Code for each credit earned or carried and listed on the worksheet.

## Column C - Credit Available for use this year

Using the amounts from your prior year Worksheet, Column F, and current year Schedule 1299-D, Step 3, Column I, list the total credit available for use this year that corresponds to the expiration date in Column A and Credit Code in Column B.

## Column D - Tax Calculation

In this step you are subtracting the income tax credit from the income tax due as follows:

- Subtract the amount on Line 1, Column C from the amount on Line (a) at the top of the worksheet and enter the total on Line 1, Column D.
- Subtract the amount on Line 2, Column C from the amount on Line 1, Column D and enter the total on Line 2, Column D.
- Continue subtracting Column C of each line from Column D of the previous line and entering the amount in Column D until you have subtracted all available credits listed on this schedule (or additional schedules) **or** when the Column D amount becomes zero or a negative number.

**STOP** calculating when Column D becomes zero or negative. Enter N/A in Column D below the line when Column D becomes zero or negative.

## Column E - Credit Applied

- If the amount in Column D is zero or positive, transfer Column C to Column E.
- If the amount in Column D is negative, add the negative amount in Column D to Column C and enter the total in Column E.
- If Column D is N/A, write "0" in Column E.

## Column F - Credit Carryforward

Figure your credit available to carryforward to next year.

- If any of the credits listed on the Worksheet have an expiration date that coincides with or is prior to the close of your tax year, enter "0" in Column F. This is the final year that this credit may be used or carried regardless of any unused amount.
- For the rest of the lines, subtract Column E from Column C and enter the result in Column F.

## Line 43

Total Column F. **This is your Schedule 1299-D Credit Carryforward available for 2022. Do not send this worksheet with your return.**

**Keep a copy of Schedule 1299-D and this worksheet for your records and for use next year.**
