### Vehicle dealers located in the Metro-East Mass Transit District (MED) portion of St. Clair County

Effective **July 1, 2004**, we will begin administering the fee on vehicle sales imposed by the Metro-East Mass Transit District.

Instead of paying the fee directly to the transit authority, you must remit the fee to us along with any tax owed on Form ST-556, Sales Tax Transaction Return.

We have revised Form ST-556 and instructions to accommodate this change.

### To what vehicle sales does the fee apply?

If the transaction is exempt from sales tax, no fee is owed. Otherwise, the fee applies to sales made by dealers located in the MED portion of St. Clair County, even if the vehicle will be titled or registered outside the MED portion of St. Clair County. We have printed the location codes of dealers located in the MED portion of St. Clair County on Page 2 of this bulletin.

**Note:** This fee also applies to sales made by out-of-state lessors who, at the end of a lease, sell a motor vehicle that is located in the MED portion of St. Clair County.

### What is the fee rate?

The fee rate is

- ◆ 0.5 percent (0.005) of the total price minus any trade-in, **or**
- ◆ \$20,

whichever is **less**.

### How do I report the fee amount owed?

We will print Line 7a, MED fee, immediately below Line 7, Retailer's allowance if filed on time, on Form ST-556. Report the amount of fee owed on Line 7a.

**Note:** The retailers' 1.75 percent timely-filed discount **does not** apply to this fee.

We have also changed the instructions for Line 8, Net tax due. You must include the amount of fee owed in the amount that you write on Line 8.

### Will I automatically receive a new shipment of forms?

Yes. We will send you a new supply of ST-556 forms in June. Please void and keep in your records all forms in your inventory. Begin using these new forms for sales made on or after July 1, 2004. If you do not, we may send you a notice.

### What happens if I do not pay the fee or I pay late?

If you do not pay the fee or pay late, you owe a penalty and interest. We will bill you for any amounts owed.

**St. Clair Location Codes (printed on Form ST-556)**

**Note:** Not all dealers in St. Clair County are affected, only those that are in the MED portion of the county. Please note that some municipalities are located in more than one county. These municipalities are followed by "(St. Clair)". Compare the location code listed below to the one printed on your Form ST-556 to verify whether or not you must remit the MED fee.
