Events 9-12

- Horses shall earn points as follows: 1st 50, 2nd 25, 3rd 12, 4th 8, 5th 5, 6-12 4
- The horses with the ten highest points that enter, shall compete in the finals.
- Ties shall be broke by draw.
- Owners and/or trainers shall be limited to two (2) horses in the finals.
- Horses are eligible to be claimed in each of the two legs as follows:
- The first start for a horse in the series the claiming price shall be the advertised base claiming price (plus allowances)
- The second start for a horse in the series the claiming price shall be 25% higher than the advertised base claiming price (plus allowances)
- There will be no claiming in the series finals
