Program Description	These educational programs provide offenders the statutorily mandated level of education through the adult basic education program. In addition to the mandate, offenders are provided the opportunity of education through adult basic education, GED classes, and associate degree programs. These opportunities can be utilized to gain employment post-release. Studies in Illinois consistently demonstrate recidivism is significantly reduced when offenders participate in these types of educational programs. These programs also allow offenders who participate to earn educational service credit that reduces their time of incarceration.
Target Population	Offender population that meets programmatic qualifications, standards and guidelines.
Activities	Educational programming provides a platform for inmates to receive adult basic education classes and the opportunity to obtain their GED.
Goals	Reduce the recidivism rate; provide basic education to inmates so that they can successfully reintegrate back into society upon release.

Program Name	Parole Operations
Program Description	IDOC supervises over 28,000 adults and 300 youth statewide with approximately 331 parole agents. The Parole Division serves to address public safety and the reentry process. The division has initiated numerous programs and processes to reduce recidivism, address parolee risk to the community and provide numerous reentry services for ex-offenders. Parole provides a series of resources and graduated sanctions in a community based setting to reduce recidivism.
Target Population	Including offenders released from Illinois prisons as well as those who are serving their parole terms in Illinois from other states (via Interstate Compact agreement), sex offenders, persons on Immigration status and those mandated to electronic and GPS monitoring systems. 70% of this population represents substance users/abusers.
Activities	Case management activities including extraditing Illinois felons from other states, apprehending absconders, escapes and those wanted for new crimes, conducting compliance checks with local law enforcement, transporting offenders from local jail to IDOC, approving host site placements prior to release from prisons, monitoring/documenting compliance with Prisoner Review Board mandates, facilitating referrals for treatment (substance abuse, mental health, veteran's services, employment, school, etc.), drug testing, ensuring adherence to statewide registration requirements (sex offender, murder, violence against youth, guns, arson, meth) and processing paperwork related to violations. Agents actively manage their caseloads by increasing or decreasing supervision levels in response to compliance and recommend parolees for early discharge from parole when appropriate.
Goals	The Parole Division has established three goals for this fiscal year; reduce the prison population by facilitating the release process through quickly identifying and approving placements and case transfers, reduce the parole population via level reductions and early discharge through setting statewide benchmarks and mandating every agent identify 2 compliant offenders monthly (minimum) for early discharge recommendation and effect good case management processes and outcomes by working with technical violators in a community-based setting to the extent possible, applying graduated sanctions in response to technical violations and documenting all work in the case management system.

Program Name	Vocational Programming
Program Description	Vocational program provides offenders with opportunities to acquire skill sets that can be utilized to gain employment post-release. Vocational programming is provided by community colleges and Illinois Correctional Industries. The programs offered include: culinary arts, welding, auto mechanics, warehousing, horticulture, recycling, food production and manufacturing. Studies in Illinois consistently demonstrate recidivism is significantly reduced when offenders attend educational programs. The last general study completed in 1997 by the University of Illinois found the recidivism rate to be 13.1% for post-secondary completers as compared to 39.2% of the general prison population and compared to 37.5% of a control group sharing similar demographic characteristics. The study concluded post-secondary education favorably impacts the recidivism rate regardless of prior criminal activity or length of sentence or minority status.
