Such concessions and exhibits shall contract directly with the Non-Fair Events Office. General liability is required of all such concessions/exhibits.

CAMPING

Campers **MUST** be parked in the campground located in the northwest corner of the fairgrounds. The fee is **based on current published camping fee schedule**. Du Quoin State Fairgrounds Camping office or Security will issue all campers permits. Campgrounds include: electricity, water, restrooms with showers, and dump station. You must contact Camping office or security for camping payment. **If fees are not collected, your unit may be towed at your expense.**

SECURITY

Lessee shall be responsible for all costs of additional Du Quoin State Fair Security deemed necessary by the Department. The Department reserves the right to determine the level of security staffing needed. Primary security is to be provided by Illinois State Police. It is the Lessee's responsibility to contact the appropriate police authority. State Police (618)542-2171.

INSURANCE

\$1 MILLION DOLLAR POLICY IS REQUIRED

- General Liability - \$250,000.00 PER PERSON; \$500,000.00 per occurrence and \$250,000.00 property damage. In addition, Lessee should have Worker's Compensation Insurance in the amount required by law.
- Dram Shop - \$100,000.00 PER PERSON, \$300,000.00 combined; \$100,000.00 PROPERTY DAMAGE AND \$100,000.00 LOSS OF SUPPORT.
- Host Liquor - \$100,000.00 PER PERSON, \$300,000.00 per occurrence, \$100,000.00 LOSS OF SUPPORT.

DEPARTMENT OF AGRICULTURE MUST BE LISTED AS ADDITIONAL INSURED FOR GENERAL LIABILITY INSURANCE, DRAM SHOP OR HOST LIQUOR.

******HORSE/CATTLE TRAILER PARKING******

Horse/cattle trailer parking will be designated for individual livestock shows at the time of contractual arrangements.

HORSE TRAILERS WILL ONLY BE ALLOWED TO PARK IN DESIGNATED AREAS

BARN AREAS – THERE IS ABSOLUTELY NO CAR/PICKUP TRUCK/TRAILER/CAMPER PARKING ALLOWED NEAR BARNS. ALL FIRE LANES MUST BE LEFT OPEN. ANY VIOLATIONS ARE SUBJECT TO TOWING OFF GROUNDS AT OWNER'S EXPENSE. PLEASE NOTIFY ALL HORSE SHOW PARTICIPANTS.

SET-UP/CLEAN UP Lessee shall be responsible for all set-ups

Lessee shall be allowed set-up or clean-up time for preparation of the event. If more than one day is requested for set-up or clean-up, the rate of one-half of the daily rate per day will be assessed. The additional length of time will be determined by the Bureau Chief of the Du Quoin State Fair. For set up you can have all day on Friday, Saturday and ½ of day on Sunday. **If fairgrounds equipment or personnel is required lessee will be charged the appropriate prevailing rate.**

SOUND AND LIGHT EQUIPMENT

The Horse Arena and the SIC Building are the only facilities with a permanent sound system. It is the responsibility of the Lessee to make all arrangements for rental of sound with a separate contractor and operation of any such equipment with Stage Hands Local 138 c/o Noel Dalbey, (217) 787-5440.

NON-FAIR EVENTS USAGE APPLICATIONS

Any application received by the Non-Fair Events Office that is not filled out will be returned immediately. Please be sure to complete the entire application, indicating set up times, event times, dates and clean up times. Also, be sure to indicate if you will be serving or selling alcohol. Number of tables and chairs **MUST** be indicated. The non-fair office will contact the Lessee four weeks before the event to go over final numbers and equipment needed.

EQUIPMENT AND LABOR RATES – (EQUIPMENT SUBJECT TO AVAILABILITY)
