I am writing to you in my capacity as Executive Director of Wellness Place to support the approval of Centegra Health System's Certificate of Need for a new hospital in Huntley.

Wellness Place is a cancer counseling, education and support facility located in Palatine, Illinois offering services at no cost to those experiencing cancer. In 2010, Wellness Place partnered with Centegra Health System in a pilot satellite program providing needed prostate cancer support services to McHenry County residents. As a result twice per month, a professional from Wellness Place gives prostate specific educational presentations and conducts one-on-one prostate cancer consultations onsite at Centegra Health Bridge in Huntley. This program is a joint collaboration between Wellness Place and Centegra Health System identified specifically to address a gap in prostate support services, as well as to those interested in men's health overall. 
