Mercy Crystal Lake Hospital & Medical Center, Crystal Lake 10-089

In accordance with the requirements of the Illinois Health Facilities Planning Act, Notice is given of a modification of an application for permit for a proposed construction and/or modification project (Project # 10-089) from (Mercy Crystal Lake Hospital and Medical Center, Crystal Lake, Illinois. The applicant proposes to establish a 70 bed acute care hospital including surgery and an emergency department at the SE Corner of Ste Route 31 & Three Oaks Road, Crystal Lake, Illinois. The estimated project cost is \$115,114,525.

The application is considered a Type A Modification and was modified on July 26, 2011. The modification consists of the elimination of a category of service from the proposed project. The review is scheduled for completion by September 24, 2011. Requests for public hearing must be received by the Agency no later than **September 7, 2011**. Consideration by the State Board has been tentatively scheduled for the **November 22, 2011 State Board Meeting**. Any person wanting to submit written comments on this project must submit these comments by **November 2, 2011**.

The Illinois Department of Public Health will post its findings in a State Agency Report, and the report will be made available via the internet on **November 8, 2011**. The public may submit written responses in support of or in opposition to the findings of the Illinois Department of Public Health.
