Further, a letter agreement from Oak Forest Hospital agreeing to accept the Applicants' ESRD patients for inpatient care and other hospital services at Oak Forest Hospital when needed is included. The NENC physicians who are involved in this project regularly refer their ESRD patients to the local Joliet hospitals, Silver Cross Hospital and Provena Saint Joseph Medical Center, for required hospitalization including inpatient dialysis. The physicians expect to continue to primarily utilize these local Joliet inpatient facilities for such care and the Applicants will obtain necessary associated documentation of such transfer arrangements to meet applicable CMS requirements.
