1 MR. MORADO: Okay, we'll get started.

2 I have noon.

3 Good afternoon. I'm Juan Morado, the
4 Assistant General Counsel for the Illinois Health
5 Facilities and Services Review Board. Joining me today
6 is the Board Chairman Dale Galassie. I'm going to be
7 acting as a hearing officer and facilitator for
8 Project 11-048, St. Joseph Hospital of Chicago.

9 As per the rules of the Illinois Health
10 Facilities and Services Review Board, I would like to
11 read the legal Notice into the record.

12 In accordance with the requirements of the
13 Illinois Health Facilities Planning Act, notice is given
14 of receipt to transfer ownership of a hospital, Project
15 No. 11-048, St. Joseph Hospital of Chicago. The
16 applicants, St. Joseph Hospital, Provena Health,
17 Resurrection Health Care, and Cana Lakes Health Care.
18 The applicants propose to transfer to Cana Lakes Health
19 Care ownership of a 360-bed community hospital located
20 at 2900 North Lake Shore Drive, Chicago. The project's
21 cost is \$375,362,016.

22 A public hearing is to be held by the
23 Illinois Department of Public Health, pursuant to the
24 Illinois Health Facilities Planning Act. The hearing is
25 open to the public and will afford an opportunity for

1 parties with interest to present written and/or verbal
2 comment relevant to the project. All allegations or
3 assertions should be relevant to the need for the
4 proposed project and be supported with two copies of
5 documentation or materials printed or typed on paper
6 8-1/2 by 11.

7 The public hearing will take place pursuant
8 to Part 1130.910. The hearing is scheduled for
9 September 21st, 2011 at 12:00 p.m., located at the
10 Lincoln Belmont Library, 1659 West Melrose, Chicago,
11 Illinois, 60657.

12 Consideration by the State Board has been
13 tentatively scheduled for the October 12th and 13th,
14 2011 meeting. Any person wanting to submit written
15 comments on this project must submit these comments by
16 9:00 a.m., September 22nd, 2011. That's the end of
17 the legal Notice.

18 If you have not done so, please sign in
19 using the appropriate registration forms. There are two
20 testimony forms, one for individuals supporting the
21 project and one for those in opposition to the project.
22 In addition, there's a sign-in sheet for individuals to
23 register attendance who are not providing written or
24 oral testimony.

25 To ensure the Illinois Health Facilities and

1 Services Review Board's public hearings protect the
2 privacy and maintain the confidentiality of an
3 individual's health information, covered entities, as
4 defined by the Health Insurance Portability Act of 1996,
5 such as facilities, hospital providers, health plans,
6 and health care clearinghouses, submitting oral or
7 written testimony that discloses protected health
8 information of individuals shall have a valid written
9 authorization from that individual. The authorization
10 shall allow the covered entity to share the individual's
11 protected health information at this hearing.

12 For those of you who came with prepared
13 written text, you may submit the written testimony
14 without giving an oral presentation. However, if you
15 choose to give oral testimony, please be as brief as
16 possible. I ask that you limit your testimony to two to
17 three minutes. After you've concluded your remarks,
18 please provide me with two copies. Prior to the
19 beginning of your remarks, please give the court
20 reporter the spelling of your complete name.

21 Individuals providing oral testimony will be called in
22 order according to sign-in. Please hold any questions
23 regarding today's proceedings until everyone has had an
24 opportunity to present.

25 We're going to begin with the

1 representatives of the applicants. I have
2 Sister Kuczynski first.

3 SISTER KUCZYNSKI: My name is Sister
4 Hedwig Kuczynski, K-u-c-z-y-n-s-k-i. I'm a member of
5 the Sisters of the Resurrection and I am on the
6 Sponsorship Board of Resurrection Health Care.

7 I am submitting my written testimony and,
8 then, the letter from Cardinal George.

9 MR. MORADO: Thank you very much.

10 MR. GALASSIE: Thank you.

11 MR. MORADO: Ms. Carol Schultz.

12 MS. SCHULTZ: Good afternoon. My name is
13 Carol Schultz. I'm the Director of Quality at
14 St. Joseph Hospital.

15 I'm submitting Dr. Roberta Luskin-Hawk, the
16 CEO of St. Joseph Hospital's testimony in support of the
17 project.

18 MR. GALASSIE: Thank you.

19 MR. MORADO: Thank you.

20 Mr. Bob Bulger.

21 MR. BULGER: My name is Bob Bulger,
22 B-u-l-g-e-r. I'm the Senior Vice President For Mission
23 for Resurrection Health Care and I'd like to submit
24 written testimony and documentation in support of the
25 project. Thank you.

1 MR. MORADO: Finally, Mr. Brian Crawford.

2 MR. CRAWFORD: Thank you and thank you again
3 for all of your hard work in the 15 public hearings
4 we've had on these various projects.

5 My name is Brian Crawford. It's B-r-i-a-n
6 C-r-a-w-f-o-r-d. I am the vice president of Public
7 Affairs for Resurrection Health Care and I am submitting
8 my own testimony in writing, as well as testimony of
9 approximately 12 community leaders around the
10 St. Joseph Hospital community.

11 MR. MORADO: Thank you.

12 MR. GALASSIE: Thank you.

13 MR. MORADO: Is there anyone else who wishes
14 to testify who has not had an opportunity to do so?

15 Hearing none.

16 Is there anyone who has testified who wishes
17 to provide additional testimony?

18 I'd like to thank everyone for submitting
19 their written comments to us. We are going to be
20 providing this information in the record. Please note
21 that this project is tentatively scheduled for
22 consideration by the State Board at its October 12th
23 and 13th meeting. The meeting location will be the
24 Bolingbrook golf course, golf club, the address for the
25 golf club is on the Board's website and that's at

1 www.hsfrb.illinois.gov. The information is already
2 posted, and you should note that the public has until
3 9:00 a.m. September 22nd, 2011 to submit written
4 comments pertaining to this project. Comments can be
5 sent to the attention of Courtney Avery, Illinois Health
6 Facilities and Review Board, 525 West Jefferson Street,
7 Second Floor, Springfield, Illinois, 62761. If you

12 adjourned. Thank you.


