I apologize for the delay. On the following page is the report for January 2012 through June 2012 and additional reporting bringing it current. The next reporting will be submitted by December 15, 2012. I hope that this will satisfy your requirements.

Also, I want to inquire if it would be possible to have this condition lifted prior to its ending date of December 2015 since all of our clinics now report charity care on an annual basis through the Annual ESRD Survey? We will also begin to submit in our applications a certification that we treat all patients regardless of ability to pay along with a certification from our physicians as well.


