- My Testimonial
- First of all it is important that I state the fact that I have never been suicidal.
- The False Claim Act" makes it illegal to turn false information into the government. I can only look at the Ideologues as a rat in a trap trying to free themselves. Sociopath does not feel that they have to answer to anyone. What one is forced to deal with are conditions that are not suitable for normal human lives.
- Those at H Douglas Singers involved in my false imprisonment violated around 83 of the Illinois Compiled Statutes. H Douglas Singers and the Mental Health Industry is being used as a false front by the ruthless, merciless, corrupt officials, corrupt doctors, corrupt psychiatrists, abusers, predators, etc.
- The "Patients Self Determination Act of 1990" gives patients the right to make choices and decisions about the types and extent of medical care they wish for themselves. Those involved in this ritual showed Disregard for Human Welfare. Guilt and shame belong to the perpetrators and abuser, not Carolyn Meece. We are always turned down for honest investigations. City Hall feels that if they refuse to acknowledge they can pretend that nothing ever happened and continue the "Criminal Solicitation at a later date.
- Investigations are supposed to go wherever the truth leads without threats, revenge, or repercussions to the Victim/Target. There is no way that H Douglas Singers, those at Janet Wattles or any place else could have legally charged Carolyn Meece with the vandalizing or arson or having a real mental illness.
- The act of diagnosing a person is nothing more than a pseudo-scientific ritual in which a person is degraded to less than a human status so that his/her basic human rights need no longer be given any consideration. They start fights and argue constantly with the victim who is in the know.
- Insurance companies do their own investigations and they can size things up in a matter of minutes. Where the City of Rockford, those at Janet Wattles, and H Douglas Singers first illegally demand the innocent individual be held for 10 days at \$374 a day which equals \$3740. - There seems to be no logic attached to the number of days one is illegally forced into the inept mental health system and the fact that the criminal activity and mental illness runs rampant. Putting an innocent individual in the mental ward, jail, or prison is not an efficient use of space and no crime was ever committed, except one of telling the truth, standing up for their rights, and trying to seek justice. - The system is broken. Sociopath love bondage and enslavement. The court system has been broken for decades.

- Even when some of these people get caught in their criminal activity and lie they feel they can continue to constantly deny what took place. They brag they are indispensable and it would be their word against ours supporters or us.

Carolyn is one of those who the City of Rockford, Mark Marinaro (so-called arson inspector), Steve Bishop, and Bill Born who were all at my home on Halloween, Oct. 31, 2001, who were all told to leave me alone. They also were told that I have asthma and they did not give a damn. On Nov. 16, 2001, 16 days later, they thought they could call a false emergency at Janet Wattlos so-called mental health Center for commitment purposes to H Douglas Singers. Those involved falsely stated that Carolyn Meece committed the crime of vandalizing and arson of her kitchen on Halloween, Oct. 31, 2001. - (215 ILCS 134/5)
  - (1). A patient has the right to care consistent with professional standards of practice to assure quality nursing and medical practices, to choose the participating physician responsible for coordinating his or her care, to receive information concerning his or her condition and proposed treatment, to refuse any treatment to the extent permitted by law, and to privacy and confidentiality of records except as otherwise provided by law.
  - (4). A patient has the right to privacy and confidentiality in health care.

"Stabilization" means, with respect to an emergency medical condition, to provide such medical treatment of the condition as may be necessary to assure, within reasonable medical probability, that no material deterioration of the condition is likely to result.

- What we have continually seen for decades is that investigations are closed down, victims, witnesses/"Victims of Violent Crime" are denied their "Due Process" Rights, illegally taken hostage involving false petitions and bald-faced lies, etc. I have been denied the right to the court system when constant crime has been committed. There has been a complete refusal to charge or prosecute. What one also sees is where City Workers feel they can intimidate, harass, file false petitions, enter into 'Police Brutality, false imprisonment, assault and Battery, Criminal Solicitation, etc. The City of Rockford feel they can deny anything ever took place. The cop behind the desk first told the groper to leave. Around and around the officer who was originally behind the desk and groper went instead of the officer getting on the telephone and calling for help. After he finally got back behind the desk and on the telephone the place was swarming with detectives cops. A detective asked me to help put the groper away. He stated that the guy had already groped a lady officer.
- We the abused see how abusers, predators, corrupt doctors/psychiatrists love bondage, enslavement, darkness, violence, forms of torture, etc. They are very arrogant and are surrounded by "Red Flags", They illegally demand to disappear good and honest people through the black hole of no return.
- It is outrageous that the justice system refuses to deliver justice. What we see is a number of people including corrupt psychiatrists, and cops who feel they can provoke and be aggressive. Then "Cry Wolf".

Abusive, corrupt, and controlling psychiatrists and mental health workers are rarely charged or prosecuted. In North Carolina they put cameras in different places. They started charging and prosecuting workers for their violent acts, neglect, people dying, etc. The workers were defrauding records, not doing their jobs, and abusing. They lied and people died.

- How many people really take the time to seek out records involving H Douglas Singers, and other abusive places and look at what is being illegally stated against them. Everyone needs a "Power of Attorney for Health Care", A Living Will, etc. Not all people who work at H Douglas Singers are dishonest, abusive, or into illegal forced drugging. There are a majority of them that fit in this class.
- Medical Neglect and endangering the health and life of a hostage. They only want to hear what they want to hear. The withholding of needed medicine appears to be used as a bargaining chip. Carolyn Meece paid \$30 for her Glaucoma eye drops and had to have a neighbor pick them up and deliver them. In the end Carolyn saw where someone at H Douglas Singers put their label on her eye drops. In the end they were refusing to turn them over and tried to say they belonged to them. They kept stalling and stalling. In reality, there never was any case.
- There must be a provision put into place stopping anyone who has been into abuse, corruption, etc. that they cannot be involved in opening up another place that is being run like H Douglas Singers has been run. Some of the female patients were hanging all over Dr. Howard Paul and he was lapping it all up. - An out-of-town Judge has told the city of Rockford to straighten up their act and they do not feel like they have to.

- Forensic Science, Time Line, Motive, Alibi, Alarm read-out, four beloved pets in my home proves Mark Marinaro, Steve Bishop, Bill Born, and others lied.
- If someone is trying to show you patience while putting emotional pressure on you or rushing you along, this is a lie in action.
- What does take place is Mob Action, Mob Mentality, Mob Rules, and Kangaroo Court with them acting as the Judge, Jury, and Executioner. Constantly provoking in which to get a reaction to "Cry\_Wolf".
- Survivors recognize psychiatry based on coercion, force and violence as a crime against humanity since it denies individual the status of a human being, endowed with inalienable Human Rights, by describing their soul in a biological - medical fashion as "ill" and having a biological-medical illness". Psychiatrist thinks that this legally justifies all forms of violence against them. It violates the 8th Amendment to force food targets psychiatric mind altering drugs.
- Many of us our only crimes are because we have become independent while other are desperate. Then they lash out with tactics they think will work and will even predict a catastrophe. I refuse to sugarcoat anything from other than it really took place in reality. I refuse to die a coward. There never was any emergency and it was all fabricated. "Theatrical Hoax", It is all staged. "Inside Job"
- A person who has not committed any crime but is illegally held for a false confession would violate substantive due process. The truth is a Defense. One does notice that those who refuse to deal with reality and truth can get very belligerent, obnoxious, arrogant, and violent. What proof do they have that psychological drugs normalize brain chemistry? What proof does the American Psychological Association and NAOMI have that emotional disorders are biologically based? What proof do they have that powerful drugs alleviate, and don't in fact exacerbate emotional disorders? And what authority justifies and empowers them to routinely and unilaterally coerce and force people into treatment? It cannot be considered treatment when it is done under force. It then becomes Indoctrination. It constitutes the same as rape. It has been reported that drug companies fund NAOMI. Some mothers have stated that they joined NAOMI and stopped supporting them because they saw what the psychiatric drugs were doing to their child. There are stories of how they have made nightmares out of children's lives and the child died as a result.
- "Dr. Thomas Szasz, has stated that psychiatry is the most destructive force that has affected society within the last 50 years. Dr. Loren Mosher resigned from psychiatry in 1998, he stated that it was all about politics and did not want any part of the corruption and drugs. As one doctor stated they can teach a 5th grader everything in one weeks time what psychiatry is all about.
- Munchausen Syndrome by Proxy, Hero Syndrome, infliction of Stockholm Syndrome, Magnificent Narcissist Self-Love Narcissism Revisited", suffer from a "Grandiose Self Worth", breached the fiduciary trust, They have committed "Unspeakeable Crimes Against Humanity" Those who suffer from "Munchausen Syndrome by Proxy, and Hero Syndrome can be considered "Serial Killers" depending on how many people have died.
- All victims or survivors have to do is to return to the scene of the crime or crimes either mentally or physically and it is instant recall or flashbacks. Recall can be triggered in a number of ways. There is a definite stench to the records of Janet Wattles and H Douglas Singers. Those from collection agencies refuse to do their dirty work because they do not want to go to prison with them. With proper medical, not psychiatric - screening, people could be properly treated medically and lead healthier, happier lives. It is time to stop the bullying and criminal behavior. Also, flashbacks are a natural process after criminal activity has taken place. Those at Janet Wattles cannot exploit. It is not any illness.

- It is not hard to remember how viciously my supporters and I were attacked. I was illegally forced to stay in an environment that was a threat and danger to my life, health, and well being. When I was presented with a folder asking if I had a "Power of Attorney for Health Care", Living Will, a paper about NAOMI, there was no paper involving "Patients Rights" It all raised "Red Flags". "Red Flags" were constantly popping up.
- Carolyn Meece was of sound mind and Carolyn Meece had the right to leave both Janet Wattles Mental Health Center and H Douglas Singers. No one had any right to stop her when she wanted to leave and go to work or back home. Under the law and the Constitution, cruel, inhumane and degrading treatment cannot be used. Forms of torture cannot be used anywhere in the world. Without a real disease to cure, arguments in favor of medication hold no water. A victim/target cannot be taken hostage in which to build a false case. Indoctrination is the ultimate refuge of mental health scoundrels.
- Illinois Compiled Statutes 405 ILCS 5/2-107.1 (D) that the benefits of the treatment outweigh the harm. When it comes to being held hostage involuntarily for illegal purposes it is worse than being raped. It leaves lasting psychological scars. The records read like they either have voices in their head or answer their own questions. In fact all this illegal activity put Carolyn Meece's life, health, and well being in great danger. Corrupt and controlling doctors/psychiatrists feel they can rip health insurance policies off for tens of thousands of dollars at each Deja Vu. As a matter of fact, there is not enough money in this world to ever make them satisfied, to solve problems that were created by controlling and sick people, or the people including themselves who helped create it in the first place.

It is no wonder the morals of society are in the toilet and sewer and the rot and decay of our society continues. Carolyn Meece has lived under security since early 1989. The so-called arson inspector and others involved thought they could throw out the alarm readout and concoct their own story. On, Halloween, Oct. 31, 2001, Mark Marinaro left with his tail between his legs. He left trying to make Carolyn Meece out to be a liar and falsely stated "your alarm was not going off when you got home." My first words to my neighbor on 10/31/2001, Halloween night, the night of a full moon when all kinds of weird and strange things happen were: "Since my alarm was going off when I got home, I don't understand why no one is here yet." Mark Marinaro or any of those involved did not have any right to go to Janet Wattles nor did they have any right to distribute pictures of the aftermath of the fire in my kitchen. It was an invasion of my privacy rights. No one had any right to constantly interrogate. There are also others who refuse to abide by the law.

- According to the law no physical or mental torture, or any other form of coercion may be inflicted to secure information and anyone who refuses to cooperate may not be threatened, insulted or exposed to any unpleasant or disadvantageous treatment of any kind. Many psychiatrists are nothing but troublemakers. Their delusions and false accusations had absolutely nothing to do with whether Carolyn Meece got her arson claim paid by her homeowner's insurance company. There is no excuse for people who refuse to see and accept the truth that is right in front of their face.
- Psychiatrists are not experts. They will report their own delusions and psychosis in a court of law.
- It is illegal to use the mail, telephone wires, etc. for any kind of fraud.
- Contempt-of-Court" - as the case was dropped by the States Attorney's office on 11/26/2001, Pauline Myers and Dr. William Wood of H Douglas Singers were still harassing and intimidating Carolyn. In reality there never was any case. Carolyn Meece was never home or could have been involved in any way, shape, or form. There are still abusers and corrupt people in medicine that are determined to frame Carolyn for a crime that Carolyn Meece was never involved in. Those that defrauded records absolutely refuse to correct them and abide by the law.
- Emotional Blackmail, Soul Murder, Elderly Abuse, Fraud

- What criminally takes place is the illegal demand to use numerous false labels and illegally force-feed a dangerous concoction of mind-altering drugs which evil side effects equal the false labels. Early to bed. Early to rise. Fish all day. Tell big lies. The stress is enough to kill.
- A storyteller is a person who tells a story and hopes the other person does not have a good memory.
- "Night Mare Man", man-made crisis, Shock & Awe, hostile take over, viciously attack the memories, illegal false emergency, illegal demand to throw out 19 years or more of criminal activity and telling bald-faced lies while they are illegally holding one hostage against his/her will, Illinois Compiled Statutes, and the law. They are falsely stating "No one is doing anything to you " No one has ever done anything to you." It is a game that abusers, controlling people, mental health scoundrels, the corrupt, etc. think they can play. Different strokes for different folks. The thought police always breathing down your neck or throat. The Constitution is supposed to be the supreme law of the land.
- They suffer from a "Grandiose Sense of Purpose" and "Delusional Disorder Persecutory Type", they report their Delusions, and suffer from psychosis. "Boys & Girls, Superheroes in the Doll Corner", let's pretend you are this and I am that. When I go wha, wha, wha you have to come running and that makes you my robot. Robot, Puppet, and "Zombie" and why the controlling and corrupt need their drugged up "Zombie".
- Linda Kobler went on the Suzanne Lee show and admitted that they have knowingly lied for years about the psychiatric drugs.
- Linda Kobler was the admitting nurse on 11/16/2001. It was a known factor by those involved that Carolyn Meece has asthma attacks. They were told to leave Carolyn Meece alone. Linda could hear Carolyn Meece wheezing. When Carolyn Meece reported that she was having an asthma attack Linda stated that she knew. Carolyn Meece was told there was no order for asthma medication on order. Carolyn Meece was never allowed to have any asthma medication. There was never any report if the medication was outdated so that Carolyn could order more. Carolyn Meece was told to go sit down. Linda Kobler did not even measure Carolyn's oxygen level. On 11/16/2001, they never documented on the chart that Carolyn Meece had an asthma attack or one coming on. Carolyn constantly talked to the doctor involving the problem. They falsely reported that they allowed the asthma medication on two different dates. For days Carolyn Meece was told there was no order charted for any asthma medication. When in fact, after seeing all the records. It states that Linda Kobler got an emergency ok on 11/16/2001 involving asthma medication. Linda Kobler falsified the medical history of Carolyn Meece. Then Linda Kobler proceeded to try to cover it all up by making false statements involving Carolyn Meece. It was Linda Kobler who used the word "Railroad" into the corrupt system. Linda Kobler and the abusive, violent, and corrupt demand that they are an adversary that cannot be beat. Asthma attacks are not due to anyone having any so-called mental illness. What one sees are abusive predators viciously attacking and reporting their "Delusions " and "Psychosis" and viciously defrauding records.
- "Checkmate", Victims and targets are political pawns in a world of greed and corruption. This story went from irritating, to outrageous to appalling, to downright nauseating, and scary in rapid succession. Institutionalized torture masked, ad "Treatment" is the second fastest growing industry in the United States. Treatment is an indoctrination word. It is no wonder the states are broke.
- Corrupt doctors/psychiatrists feel they can charge for services not wanted, not needed, not necessary, not legal, and not done. That which is forced under "Duress", there is not meeting of the minds. A judge has stated that everyone has a right to his/her "Due Process" Rights.

- The police cars, Sheriff cars, and Fire Equipment Vehicles are used for fraudulent activity. It involves the illegal use of taxpayer's dollars. After a horrible ordeal they will say "If your cannot answer my questions. I have to commit you." That is abuse of power and exploitation.

Hostages have every right to inspect the records and request corrections. Those at H Douglas Singers will deny that right. They do not want the hostage to know what they are illegally stating in the records. Defrauded records cannot legally be used nor transferred in any way, shape, nor form. Those at Janet Wattles were told this very fact 11/16/2001, and they refused to stop their "Criminal Solicitation". They were told to get out of Carolyn's life prior to 11/16/2001, and on 11/16/2001. There is a complete refusal by abusers, controlling, corrupt psychiatrists, corrupt medical people, and the City of Rockford to straighten up the records they have defrauded. In some instances corrupt and controlling doctors have committed HIPAA Act violations and gotten into the defrauded records without permission. Then they "Cry\_Wolf". The victim/target is forced to endure "Police Brutality" and is seriously injured and had to endure surgery for one of the injuries. It resulted in thousands of dollars of medical expenses, Pain and suffering, and Medicare Fraud, etc. They refuse to stop when told to stop or get their hands off of you. Victims do have Constitutional Rights and Civil Rights.

- The predators feel they know just how to commit what they feel is the perfect crime. A sociopath feels that he/she always know the right thing to say and do. "Assault and Battery"
- Pete and Repeat constantly takes place in records and it is an illegal tactic.
- Exploitation of a Victim/Target/Witness/"Victim of Violent Crime is against the law.
- Bait and Switch, Divide and Conquer, False Petitions, Manufacturing Evidence, False Witnesses
- Falsifying reports to try to make it look like the money is coming from a legitimate source of business.
- High Extortion - Creating a problem and trying to charge customers for the solution. The word customer is a socialist term. Investigation committee that would come armed with pens, paper, killer mind-altering drugs and buckets of whitewash. Experts state that I do have a case. Corrupt and controlling people cause the problems and come up with a BS solution. Why Rockford, IL is high in crime, violence, and homicide. We are forced to deal with "Intermittent Explosive Disorder" from abusers, narcissists, the violent, and corrupt.
- The abusers and corrupt think they can bluff and claim to have evidence when their hostage or target knows in reality that they cannot possibly have any to justify their claims.
- False Emergencies illegally take place because the controlling illegally demands complete control over everything. An individual is illegally taken hostage with only the clothes on her back. She does not have any personal belongings including medical needs. If the do not have anyone to bring them things they are shit out of luck. This also includes eye drops for Glaucoma. If anyone should try to help the hostage to stand up for his or her Constitutional or Patients Rights they call the guards to have them removed or they threaten to arrest the supporter. There is an illegal demand that the hostage can only listen to the abusers and controlling. They feel they can control who can and cannot visit the hostage.
- On 11/16/2001, I was told that I could not be arrested instead of being delivered to H Douglas Singers because I had not done anything wrong. Yet, I was constantly harassed, intimidated, and forced to endure psychological warfare with the threat by the so-called Guardianship Lawyer Teresa Berge that they could come back and arrest me at any time. I will never talk to another so-called Guardianship Lawyer. Total clean up and repairs to my kitchen were \$1740. Teresa Berge made delusional and psychotic statements that are divorced from reality. Carolyn Meece was gone for over 8 3/4 hours and it was whopper Wednesday at Burger King. Teresa Berge stated "they think that you did it before you

left for work". Because of all the corruption and criminal activity in the mental health industry and by those who feel they can "Cry\_Wolf". I had a "Power of Attorney for Health Care".

- It is time to clean up the rot, decay, and corruption.
- Fraud-In-The-Inducement, Fraud-on-the-Court, Dereliction of Duty, Refusal to Protect, "Taxation Without Representation", it is outrageous the justice system refused to deliver justice.
- It has been stated that those at H Douglas Singers have to write themselves up if something takes place. What one sees is how the abusive and controlling whom defraud records tries to being everyone's attention to their cause and asks them if they just saw what took place. Then they knowingly lie about who got into whose shoe and what illegally took place in reality.
- It is only fair that Carolyn be able to repeat their statements that those at Janet Wattles and H Douglas Singers fraudulent stated about Carolyn Meece. I hear them say that Due to the mental illness, conspiring, and defrauding the records by those at Janet Wattles and H Douglas Singers no one can rely on any of their information or facts as being true or reliable in any of their records with the name of Carolyn Meece. That is why the records and charts appear to be sketchy, it is because those at Janet Wattles and H Douglas Singers are hiding, covering up/warping the truth. The records of Janet Wattles, and H Douglas Singers consist of a fictitious character that does not exist. "Ultimate Identity Theft"
- Insurance Fraud - Debt Collection Fraud
- The continuous stress is enough to make the blood pressure rise and to kill. Stress destroys the red blood cells.
- The U S Attorney Patrick Fitzgerald took Elizabeth Loftus to task involving her not so-scientific books and inflated figures. The corrupt psychiatrists, abusers, corrupt officials, corrupt mental health workers talk about an illegal lifetime plan. They are always talking about controlled environments and need to keep your mouth shut. It is the illegal use of the so-called mental health industry and the psychiatric drugs.
- There is an illegal demands that they know all your business and that one has to fill out a financial form or they will get the information elsewhere. Three of my Illinois Income Tax Returns were stolen while Rod Blagojevich was governor. H Douglas Singers should have been closed back in 2002. The corruption was covered-up throughout by the state even by Illinois Department of Professional Regulation and Attorney Registrations and Disciplinary Commission which is a Div. of the IL Supreme Court. Lisa Madigan stated that one collection agency thinks they can claim they area lawyers office.
- Racketeering, Extortion, Exploitation, endangering the health of human lives, etc.
- H Douglas Singers or psychiatrists need the hostage to talk to different people. Then they try to say that the hostage is constantly changing his/her story. When in fact the hostage is constantly telling the same facts and it is the controlling and abusive who constantly changes things.

His/her denial of the instant offense will certainly hinder any treatment goals. If the hostage would only take the responsibility, then he/she could transfer to the rehabilitation-oriented or prison. But until he/she admitted to his/her crime, he/she would stay put. Parole denied.

That the criminal may have spared the life of the hostage only to save it as a bargaining chip, is overlooked, as also is the fact that the criminal had stolen the captives life and used it for his/her own ends.

- If anyone disagrees with a shrink that they try to say that this individual has a "Lack of Insight".
  - Manipulation of human intelligence for the purpose of mass enslavement is perhaps the most despicable and inhuman abuse of power that any one group of humans can practice on another. They demand that their victims be incapable of thinking or acting otherwise than their captors have wished. They play my testosterone can beat your testosterone. Their thoughts are irrational, delusional, and bizarre.
  - Mark Mariano, the so-called arson inspector falsely accused Carolyn Meece of moving a huge stove that had two ovens, two broilers, skillets in the top oven, a cabinet on the top of the top oven that had microwave dishes in it. My daughter states that Mark Marinaro demanded that Cheryl meet them at her mother's home on 11/16/2001, around 9:00-9:30 am and that she did not have any choice. That she was to park up the street. There was also a white van with two women from corrupt Janet Wattles so-called Mental Health Center. Also there was a man who wore a cross and she stated that he was Bill Born. They were trespassing on "Private Property" with signs posted. There is no way in hell they could have ever proved their case. "The Fb is In", Corrupt business deals, racketeering, "No talk programming"
- I was in bed asleep and was told by the neighbors about them all being at my home. Yet, there was never anything stated in the records of those from Janet Wattles as to being at Carolyn Meece's home. There have been problems with Janet Wattles involving abuse and psychological warfare for a number of years. Mark showed my daughter pictures of the aftermath of the vandalize and arson and also kept trying to convince Cheryl that her mother was responsible for the arson and vandalized her own home. Carolyn Meece was finally told what to do by City Hall in which to file a complaint involving Mark Mariano, Steve Bishop, Bill Born and those involved. Nothing was ever done about the criminal activity. It was never acknowledged. The Fire Department and Police Department were told in writing to stop their "Criminal Solicitation". They absolutely refuse because it has all continued. They do not feel they have to abide by the law or Constitution, Civil Rights, etc. They feel they can cater to those into criminal activity.
- Carolyn Meece caught two workers at H Douglas Singers looking at pictures of the aftermath of the vandalism and arson of her kitchen and gossiping. Carolyn Meece was forced to endure slanderous statements like "Why did you set your kitchen on fire. Carolyn Meece stated that it was a slanderous statement to make and that she did not have to put up with it. The gal then proceeded to deny that she ever made the statement.   - Pauline Myers gave Carolyn a note with her telephone number. If you need me call. Pauline is not the only abusive and corrupt person with an agenda who has done this. It is a sick game that ruthless and merciless people play. The only reason that she wanted Carolyn to call her was so that she could make hash out of it. Carolyn Meece is rarely wrong.
  - When Carolyn first spoke to Dr. William Woods, he told Carolyn that perhaps it was time that she leave town again. Not a word of this was put into the chart. Dr. Woods always had Pauline Myers in the office with him. After the court demanded my immediate release they kept stalling. They kept harassing Carolyn and continued the interrogation. They tried to tell Carolyn that she could not leave

for a number of hours. They seemed to keep hoping that her supporters would leave.

"Contempt-of-Court", The records of H Douglas Singers are not worth the paper they are written on.

- Some cops on the blogs are calling other bloggers liars, viciously attacking, and telling people that they need to take their medicine. Those into mental health are also viciously attacking those who blog. These cops get paid with taxpayers' money and they feel they can viciously attack and get their importance at other people's expense.
- Corrupt psychiatrists are known to go into corrupt business deals with abusers, predators, sociopath, etc. At a minutes notice of "Cry\_Wolf" they will go into action in order to keep their criminal games going because they have violated the law and committed insurance fraud.
- "Checkmate", the victim/target are used as pawns in the game of chess. They even talk about an illegal lifetime plan. What we have is the pot calling the kettle black. They are not reformers they are transformers. There are absolutely no honest investigations.
- The corrupt always seem to have someone listening to the radio. After someone has spoken out another person will call in trying to discredit the person who just spoke out. Then some are later penalized. The thought police are always around. It is all about staying in power.
- During the 1982 child molestation case Detective Piccirilli stated involving my daughter. "Perhaps if I punish her. She will see things my way." It was Piccirilli's testimony and not the truth. Steering and demanding to put words in a victim/target's mouth is illegal. They also stated that if she did not testify to what they wanted in court that they would come after her. The alleged (how I hate that word) child molester was never prosecuted and in the end they were demanding to come after my child. Others told me that the alleged child molester and his wife went to court and committed "Perjury" a number of times. They made a number of false accusations and for years I was harassed, threatened, and forced to endure her constant wrath and threats. A number of people watched this case and what criminally took place in reality. They thought they were free to do whatever they wanted without fear of being charged or prosecuted. Those at Janet Wattles were not there for us when we went to court nor during all the harassment, intimidation, death threats, etc. One day I went directly from the courtroom to the telephone and called both those at Janet Wattles and the coroner's office. The coroner was Sue. Since then Linda Johns apologized to both my daughter and I and stated that she was ashamed of herself. Piccirilli predicted that something terrible would happen in the family.
- The "Criminal Solicitation" and fraud never stops because the corrupt, abusive, and violent feel they are untouchable. Rockford constantly violates the laws and that is why crime, violence, and murder are so bad.
- Under the law abuse and crimes are supposed to be reported. It is not being reported. In fact the corrupt and controlling are part of the problem along with the mental health industry.
- Linda Kobler stated on the Suzanne Lee Show that if something happens at H Douglas Singers that they are supposed to write themselves up. What they do is to falsely report trying to make it look like the hostage or her supporters caused the problem, got into their face, etc. Also that a patient accused her of just cutting off her head. When Linda told this story. I knew exactly what the patient was referring to. The abusers will ask different workers if they saw what just took place. Then proceed to lie about that which took place in reality. No one expects it to go from daylight to midnight in a matter of seconds. It is all about control and getting rid of any true support for the hostage. They did not want Carolyn Meece to know her rights or have any real support. They did not want Carolyn to be able to see the defrauded charts. In fact, Carolyn Meece tried to push the issue buy to no avail. I never told Linda Kobler that I saw what she did to my friend and supporter or that I remembered it all. I was very elated that my supporters had the guts to stand up to Theresa Berge, put her in her

place, then come back, and helped rescue me from the clutches of cold-blooded merciless controlling bullies. Rockford, controlling people, and the abusive and controlling people of Janet Wattles feel they can screw people with their health insurance and their own money. Carolyn Meece refuses to pay for their "Theatrical Hoax" and Emotional Blackmail.

- Abusers, the controlling, and corrupt feel they can falsely claim they are the law and there is no escaping their wrath.
- When Money Magazine appeared in town without announcing they were coming. Those at the Mayor Box's Office, those at the newspaper, and a number of people reported they were constantly frantically calling Money Magazine demanding that be told the reason they were here unannounced. Abusive people think they should be given everything on a silver platter without really deserving it.
- Local laws do not come before the Constitution or the law of the land. They do not come before the Illinois Compiled Statutes, etc.
- When those at H Douglas Singers stated on the release that one is not to have any alcoholic drinks. One has to wonder if they illegally drugged the food. There is a website that claims that it is illegally being done if one refuses to take the evil killer psychiatric drugs.
- The Rockford Register Star has made demands on some people that they should not reconstruct crime scenes. They claimed that the people in the town of Rockford do not rock the boat. Those in the so-called mental health industry and others do not feel they have to answer to anyone. What is good for the goose is good for the gander. Ideological campaign they need to prove that they are fighting against something. There has been constant Mayhem and Soviet Ideology in the city of Rockford.
- Some controlling and abusive people pronounce themselves to be prophets or the voice of God. There is always some predator seeking and out to devour his/her next victim/target.
- When it involves corrupt and controlling doctors, etc. who violate the HIPAA Act, one might see "no, she does not want anyone to know that she is here." There is an illegal demand in some places that the hostage cannot make any telephone calls. False emergencies are about complete control.
- "Primal Fear", a person of two faces sooner or later forgets which is which.
- Staged and Premeditated acts
- I was right in my analysis of 1982, 1988 and thereafter. It has been proven that I have my memories and I am rarely ever proven wrong. Like Detective Piccirilli in 1982 we do not need anyone that we have to tell things according to his/her Ideology and Propaganda. Steering is illegal and so is demanding to put words into a victim's mouth.
- What we are forced to deal with are massive power grabs. Just because the mental health scoundrels falsify records does not mean there is any progress in the hostage's mind or life. The records are defrauded accordingly even before they are illegally taken hostage and thereafter.
- The U S Attorney took Elizabeth Loftus to task involving her not-so scientific books and falsely inflated figures.
- A number of people feel they are free to bully, talk about their hit list, who they should put a contract out on, tell bald-faced lies, threaten others, etc. These same people are put into position of power. One will even hear "I don't know of any other company that has as much fun as we do." As one man has stated over the radio. "The graveyards are full of people who have thought they were indispensable. One sees that controlling people demand they are an adversary that cannot be best.

- It has been proven that the psychiatry drugs will cause obesity. I have even spoke to some that claim they gained all the weight after being put on the psychiatric drugs. Those who illegally demand to hand the psychiatric drugs out like candies and illegally demand they are the answer to all the criminal activity have knowingly lied about the psychiatric drugs for decades. There are corrupt psychiatrists who feel they can give psychopaths the right to continue to break the law and even falsely use them as a witness against those who bodies and minds they have violated. They also feel they can inflict "Stockholm Syndrome" and that one had better bond with them. The abusers and corrupt feel they can make the illegal demand that the hostage cannot consult with an honest lawyer who will work for them. There are a number of ways in how the memory is triggered.
- What one sees used is Mind Control, Brainwashing, or Thought Reform, the thought police are constantly trying to breathe down or necks or throats. The illegal demand to try to put words into our mouths and constantly trying to tell us how we should feel. "Soul Murder", The Right to "Freedom of Speech" in which to speak the truth is denied.
- I remember seeing Mary Ann Abate who worked at Janet Wattles Mental Health Center on 11/16/2001, in the room with Dr. Johnson in the 1990's. I hope that I did not spell his name wrong. He was obnoxious and into psychological warfare. I walked out and stated that I was not going to put up with the abuse or psychological warfare. It is a victim's legal rights. If I am not good enough to listen to then I have had it with him. All this corruption and violence is why crime, violence, and Rockford is full of chaos. The note about Carolyn Meece going AWOL is a "Delusional" and "Psychotic" statement to make. Corrupt doctors feel they can get into defrauded records full of HIPAA Act Violations, feel they can make false 911 calls, false fire and police reports, declare a false emergency and illegally commit against the victims Constitutional and Civil Rights and Illinois Compiled Statues. They also feel they are free to commit insurance fraud and Medicare Fraud.
- Teresa Berge, so-called Guardianship Lawyer who had her name posted at Singers told me something that I already knew. Those at Janet Wattles Mental Health and H Douglas Singers cannot go from one false label to another and spin. They cannot build a false case after taking one hostage. She stated that they could release me at anytime and that I did not have to wait until the court case. States Attorney, Paul Logli stated on the radio that one could be only held for five days. I was illegally held for 10 days from 11/16/2001 - 11/26/2001. They ruined my Thanksgiving plans. Teresa Berge told me that they could release me at any time and I did not have to wait for the court case. Teresa stated that she would talk to Dr. William Wood and get me released. I was never released and Teresa Berge was looking at the defrauded charts on 11/26/2001 and acted like they were a big secret. Teresa Berge also said to me on 11/26/2001, that those involved could come back and arrest me. It would be an illegal arrest. Carolyn Meece never committed any crime nor did anything wrong. I never was allowed to see the charts while being held hostage. Anyone with a "Conflict of Interest" cannot have his/her name in any given place. The Prairie State Legal Service

refused to take my case. Teresa Berge tried the same thing as what she claimed that those at H Douglas Singers could not do.

Those at Attorney Registration and Disciplinary Commission which is a Div. of Illinois Supreme Court refused to do something with Tessa Berge and another corrupt lawyer. I also have every right to have my case that I was filed with the Illinois Department of Professional Regulation re-opened.


- We constantly see how the abusers and corrupt demand they are going to take over Rockford. Much of psychiatry is a destructive cult. "RickRoss.com"
