
The scope of this project was the discontinuation of the Intermediate Care Facility for the Developmentally Disabled category of services at the Jacksonville Developmental Center in Jacksonville, Illinois.

The Health Facilities and Services Review Board approved Project No. 12-074 on October 30, 2012. At that time it was acknowledged that the anticipated completion date of October 31, 2012 was not achievable and a projected new completion date of November 21, 2012 was set. On November 15, 2012, a permit renewal was submitted requesting an extension of the Project Completion Date to December 3, 2012.

On November 27, 2012 the Jacksonville Developmental Center discontinued serving individuals on its campus.
