I write in opposition to the merger of Chicago's Holy Cross Hospital with Sinai Health System.

Such a merger would negate the spirit of cooperation between the hospital and Chicagoland's Lithuanian community. This relationship began in 1928 as a partnership between the Sisters of St. Casimir and the Lithuanian Roman Catholic Assistance Society. Chicago's Lithuanians have supported Holy Cross Hospital morally and financially for over eighty years.

It has come to my attention that the fact of Lithuanian community collaboration with Holy Cross Hospital is being denied by some of the parties involved. Our Research Center possesses material which proves otherwise.

I urge the Board to reject the merger. Thank you very much for your consideration.





Dear Members of the Illinois Health Facilities and Services Review Board:

The proposed assignment of Holy Cross Hospital to the Mount Sinai group is a wrong-headed decision, precipitously being made without full disclosure and community participation.

Lay Foundation

As a longtime resident of the southwest side of Chicago I am intimately familiar with the history and operation of Holy Cross Hospital. It is a unique Catholic institution since it was initiated and founded by the laity. Loyal citizens, hardworking immigrants, literally laid the foundation for the establishment of the hospital and then entrusted its management and care to the Sisters of St. Casimir.

Inherent Contradiction

In this instance this trust is being violated and thus this letter is submitted in opposition to the proposed transfer of Holy Cross Hospital to Mount Sinai. Mount Sinai, which will become the sole corporate member, has had no substantive historical or foundational connection with Holy Cross Hospital. Not only is there a failure in a foundational context but there is a fundamental contradiction in the philosophies and ethical norms espoused by each of these entities. The difference is most starkly seen in the radically different views regarding the inception of life and norms dealing with its preservation. This inherent contradiction cannot be reconciled and is doomed to failure. One cannot serve two masters.

An 82 million Dollar Giveaway

Thus the proposed giveaway of an 82 million dollar asset (Holy Cross Hospital) to an entity that is antithetical to Holy Cross's very essence is a gross violation of Holy Cross's mission and exhibits a brazen disregard for the intention of the founders and donors of Holy Cross Hospital.

Vatican Approval Required

In that Holy Cross Hospital is a Catholic institution it is subject to particular norms which must be adhered to with respect to any contemplated change in ownership. The approval of the local ordinary, the Archbishop of Chicago Francis Cardinal George, is required and ultimately approval must also be received from the Vatican.

Cardinal Asks for Consideration of St. Anthony — Not Mount Sinai

We have been informed that the Cardinal has requested that Holy Cross Hospital enter into an agreement with a different hospital — St. Anthony, a locally situated authentically Catholic hospital. This is confirmed in a letter I have received from the Archdiocese, wherein it is stated: “You should know that the Cardinal has already asked the Sisters to consider entering into a partnership with St. Anthony”. See letter of August 29, 2012 as attached.

It would appear that the Archdiocese believes that Holy Cross Hospital should affiliate with St. Anthony hospital in that both are established Catholic institutions and then there would be no need through an artificial construct to maintain the “catholicity” of Holy Cross Hospital.

We concur with the Cardinal’s suggestion as that would be a far superior choice and fully congruent with Holy Cross Hospital’s mission.

Absent the Cardinal’s and the Holy See’s approval this project cannot proceed.

Common Sense Dictates Alternate Choice

The application should be rejected because no consideration or even acknowledgement is made regarding the St. Anthony option which by all indications is one supported by the community and the Archdiocese. Common sense dictates that it should be the logical choice.
