The Public Hearing for the above referenced project was conducted on November 15, 2012. This document is being submitted to provide general information not addressed during the Public Hearing, and to address a number of issues raised through testimony provided in opposition to the project.


General

38 individuals provided testimony in support of the project, and 22 individuals provided testimony in opposition to the project. In general, presenters in support of the project focused on improved accessibility to hospital services for the residents of north central and northwestern Lake County, while those in opposition to the project highlighted the anticipated impact on existing hospitals.

There was a significant difference in the backgrounds of those in support and in opposition to the project, as summarized below:

This project differs from all other projects proposing the establishment of a new hospital in the greater Chicago area over the past ten years, including the projects recently proposed in McHenry County, in a very significant way. This project, unlike the others, adds only a handful of beds to the Planning Area's Inventory, as a result of the applicant's pledge to discontinue 108 beds at Vista Medical Center-East. This project re-distributes Vista's beds, to that part of Lake County void of beds, as documented in the map below, which shows all of Lake County's hospitals being located in the southeastern half of the County. In addition to the re-distribution of beds, I hereby certify that no categories of service currently provided on Vista's Waukegan campuses will be discontinued for a minimum of three years following the completion of the proposed project.



The remainder of this letter will address certain issues raised and allegations made by those persons, primarily representatives of other area hospitals, providing testimony in opposition to the proposed establishment of Vista Medical Center-Lindenhurst ("VMC-L").

1. Accessibility is not an issue for residents of north central and northwestern Lake County.

It is likely that no other residents of the metropolitan Chicago area are required to drive as long to a hospital as those living in the north central and northwestern portions of Lake County. Countless individuals, including first responders, elected officials, and area residents addressed the lack of reasonable accessibility to a hospital through their supportive testimony, and I focused on this critical issue during my opening remarks at the Public Hearing. As the population of this area continues to grow, the roadways are becoming more congested, and drive times will only increase over the coming decade.

Because the experienced drive times identified by so many area residents and first responders were questioned by the opposing hospitals, the applicants have commissioned an independent drive-time study (findings attached), which supports the statements of the area residents, first responders and elected officials. The results of that study are attached.

The following are examples of the existing drive times documented in the study. Please note that the drive times identified in the independent study and identified below do not include the time required to summons EMS personnel, or to prepare the patient for transport to a hospital.

- From US Route 12/State Park Road, Ingelside: 48 minutes to Vista-East, 37 minutes to Condell, and 19 minutes to Vista-Lindenhurst
- From US Route 12/Spring Grove Road, Spring Grove: 55 minutes to Vista-East, 46 minutes to Condell, and 23 minutes to Vista-Lindenhurst
- From Cedar Lake Road/Rollins Road, Round Lake Beach: 35 minutes to Vista-east, 32 minutes to Condell, and 13 minutes to Vista-Lindenhurst

2. The establishment of VMC-L will harm Advocate Condell Medical Center's Level I Trauma Center.

VMC-L will not take Level I trauma patients from Advocate Condell Medical Center ("Condell"). VMC-L will, as is the case with most general acute care hospitals operate an emergency department designated by the Illinois Department of Public Health as "comprehensive", and Condell will continue to be the only Level I Trauma Center in Lake County. Patients requiring Level I Trauma Services, as determined by the Emergency Medical Services ("EMS") serving the area, will continue to be transported to Condell. While undeniably a valuable service to the residents of Lake County, IDPH data documents that in 2011 only 2.71% of the patients treated in Advocate Condell's Emergency Department were classified as trauma patients.

3. The establishment of VMC-L will result in a duplication of services.

The establishment of any hospital results in a duplication of services, by definition. VMC-L, as proposed, is designed to provide those basic inpatient

services provided by virtually every other community hospital—medical/surgical beds, ICU beds, and an obstetrics program—but not those tertiary care services that are being provided by other hospitals, such as open heart surgery, neonatal intensive care, or a Level I trauma center. The outpatient services that will be provided, are the same services that are being provided now on the Lindenhurst campus, including imaging, laboratory, PT/OT, and outpatient surgery. The central issue appears to be the balance between reasonable accessibility to basic inpatient services and duplication of inpatient services.

4. The applicant's will abandon Waukegan upon the opening of VMC-L.


Nothing could be further from the truth. First, as documented and discussed in the Certificate of Need Application, VMC-L is being designed to operate as a satellite of Vista Medical Center-East, in Waukegan. As a result, the Lindenhurst hospital's space program (included in the application) provides for a minimal amount administrative space. Second, VMC-L's business plan assumes that most non-patient care services will be provided on a "shared time" basis with VMC-E, as is currently the case with Vista Medical Center-West. Third, since acquiring the Waukegan hospitals in 2005, Vista's parent has made capital improvements, both in the form of equipment replacement and acquisition, as well as renovations to the physical plants that would not have been made, had there been plans to leave Waukegan.

5. Existing hospitals would be forced to eliminate programs if another hospital were to open.

These assertions were made by Advocate Health Care's two Lake County Hospitals and Northwestern Lake Forest Hospital. Advocate's publicly-available financial statement shows an operating income in excess of \$300M in 2011, and Northwestern Memorial Healthcare's financial statement identifies an operating income of \$92.4M for YE August, 2011. There is no reason to believe that either of these systems will not be able to afford to continue to operate their Lake County hospitals, with their current program complements.

PART I. PROJECT OVERVIEW

Per your request, *Gewalt Hamilton Associates, Inc.* (GHA) has conducted a series of drive time surveys for the proposed Vista Health Hospital in Lindenhurst. Drive times have been collected for two intersections in seven separate communities. For each intersection, drive time surveys were conducted between three locations: 1) the existing Vista Health Hospital at 1324 Sheridan Road in Waukegan, 2) Advocate Condell Hospital at 801 S. Milwaukee Avenue in Libertyville and 3) the existing Vista Campus / proposed hospital site at 1050 Red Oak Road in Lindenhurst.

Exhibit 1 illustrates the locations of the existing Vista Hospital building, the existing Advocate Condell building in Libertyville, and the proposed hospital site on the Vista Campus in Lindenhurst.

The drive time surveys were conducted in accordance with the guidelines followed by the Illinois Health Facilities Planning Board (HFPB) as published in Chapter 77, Section 1100.510 of the Illinois Administrative Code. *See Appendix I*

Exhibits and Appendices referenced in the text are centrally located at the end of this document in the Technical Addendum.

PART II. TRAVEL TIME SURVEY RESULTS

Directions and travel routes were selected using a combination of local knowledge and directions published by Google Maps© to determine the most efficient travel routes. Due to the ongoing construction and associated exaggerated delays at the intersection of IL Rte 137 (Peterson Road) and IL Rte 21 (Milwaukee Avenue) this intersection was avoided to the extent possible when routing to and from the Condell Hospital location.

The representative communities as provided by Vista Health for this study and their selected representative intersections (as selected by GHA) included:

 - A. IL Rte 132 (Grand Avenue) @ Cedar Lake Road
 - B. Fairfield Road @ Monaville Road
4. Grayslake (60030)
 - A. IL Rte 120 @ Alleghany Road
 - B. IL Rte 45 @ Washington Street
5. Round Lake Beach (60073)
 - A. IL Rte 83 @ Monaville Road
 - B. Cedar Lake Road @ Rollins Road
6. Ingleside (60041)
 - A. Fish Lake Road @ Nippersink Road
 - B. Fairfield Road @ Rollins Road
7. Spring Grove (60081)
 - A. US Rte 12 @ Winn Road/ Spring Grove Road
 - B. Johnsburg Road / Wilmot Road @ Main Street

Appendix II contains the written directions for each intersection to each health facility.

Exhibits 2 A-N illustrate the locations of the key intersections, medical facilities and the routes taken between.

Travel times were recorded to and from the various intersections and medical facilities. The surveys were conducted in December 2012 and January 2013 during the weekday non-peak period from approximately 8:30 AM to 3:30 PM. These times were chosen to ensure that the prevalent travel patterns on the road system would be accounted for. Generally, no unusual delays occurred during the travel runs such as foul weather (e.g. heavy snowfall or rain), road construction, or emergency vehicle activity that would adversely affect the volumes or travel patterns. As noted previously, known construction delays were avoided to the extent possible. GHA reviewed local school calendars to ensure that school was in session during the days of all of our time trials.

Exhibits 3 A-N summarizes the observed travel time results. All travel times were recorded at a starting roll or in other words, the stopwatch was started, as the drivers were ready to travel forward. However, in reality, an ambulance crew will require an additional few minutes (3 to 4 minutes) to pick-up and / or drop-off the patient at the hospital thereby increasing "door to door" travel times. All starting and ending points for medical facilities were as near the Emergency Room or Main entrance as possible without obstructing actual emergency traffic or patrons. In addition to individual trial times, Peak one way and round trip times are provided.

Key observations include:

- One way travel times varied between a low of 5 min to a high of 55 min.
- Similarly, two-way or round trip travel times varied between a low of 9 min to a high of 1 hour and 46 minutes.

The following table summarizes the Average peak one way travel times from the 14 intersections to each of the hospital sites:




Exhibit 1 - Hospital Locations

Exhibit 2A: Intersection 1A - Antioch


Vista Lindenhurst Drive Turn Study







Exhibit 2D: Intersection 2B - Fox Lake






Exhibit 2E: Intersection 3A - Lake Villa






Exhibit 2H: Intersection 4B - Grayslake













- 9) HFPB recognizes that some long-term care facilities may have a primary market area that is not contained within the planning area in which the facility is located. Placement in long-term care facilities may be influenced by such factors as, but not limited to: location of next of kin or relatives; seeking services of a specialized nature such as treatment for various diseases or disabilities; or seeking services related to religious, ethnic, or fraternal needs. Because of the significant degree of mobility that is exercised in seeking long term care services, HFPB shall not allocate portions of a facility's beds and services to more than one planning area.
- d) **Normal Travel Time Determinations**
Normal Travel Time for proposed projects shall be the time determined by MapQuest, Inc. (MapQuest – www.mapquest.com) multiplied by an adjustment factor that is based upon the location of the applicant facility.
 - 1) For applicant facilities located in the City of Chicago, Normal Travel Time shall be calculated as MapQuest times 1.25.
 - 2) For applicant facilities located in the Chicago Metropolitan region, including counties of Cook (excluding Chicago), DuPage, Will, Kendall, Kane, McHenry, Lake and Aux Sable Township of Grundy County, plus the counties of Winnebago, Peoria, Sangamon and Champaign, Normal Travel Time shall be calculated as MapQuest times 1.15.
 - 3) For applicant facilities located in any other area of the State, Normal Travel Time shall be calculated as MapQuest times 1.0.
 - e) Independent Travel Time Studies may be prepared and submitted in addition to the above to refine or supplement the determination of Normal Travel Time, provided that they are conducted as follows:
 - 1) The study is conducted by an engineering firm pre-qualified in traffic studies by the Illinois Department of Transportation (IDOT) or prepared by a Professional Engineer also certified by the Institute of Transportation Engineers (ITE) as a Professional Traffic Operations Engineer (PTOE).
 - 2) A Travel Time shall consist of a minimum of three round trips for each defined survey route.
 - 3) No more than one third of the round trips shall start or conclude during a

rush hour period, i.e.:

Morning Peak Period: 6:30 AM-9:30 AM

Evening Peak Period: 3:30 PM-6:30 PM

- 4) The routes used for determination of Normal Travel Time shall be reasonably direct.
- 5) Average travel time for a one-way trip will be considered.
- 6) All travel routes and calculations of Normal Travel Time are to be documented and sealed by the responsible Professional Engineer.

STATE BOARD NOTE: Calculations produced by MapQuest, Inc. have been used as a basis for the above methodologies. MapQuest assumes vehicular travel at posted speed limits, with some adjustment for number of intersections and turns. The adjustment factors in subsection (d) are intended to reflect additional factors related to density of population.
