Dear Mike:

Enclosed are physician referral letters as required by your rules. We do not believe they are necessary, since we are transferring beds from Vista East to establish Lindenhurst Hospital, but since the issue was raised by opposition we are providing them. The information referred to in the Freestanding Emergency Center Medical Director's letter is in fact in our application and materials - just not in the form of a referral letter.

We also note that many physicians who have expressed a desire to support and join the Lindenhurst Hospital Medical Staff (and thus would refer patients to the Hospital) expressed discomfort in providing referral letters since they are on staff at opposition hospitals. We understand the difficult situation they are in.

Finally, we note that your rules ask for referral letters concerning patients referred to other area facilities in the past 12 months. In fact, our main argument supporting the establishment of Lindenhurst Hospital is that there are not any area facilities to provide inpatient care to the zip codes that Lindenhurst will serve. While it is true many of the patients go to Vista East, Vista West and other hospitals that oppose Lindenhurst this is in many instances out of necessity as there are no other options.

I urge the Board to consider that Lindenhurst Hospital will provide access to care that area residents just do not have at this time, without undue hardship.

Dear Ms. Avery:

I am the Medical Director of the Vista Free Standing Emergency Center located in Lindenhurst. In 2012, the FEC referred 1074 patients for inpatient admission to area facilities (although in fact there are no real area hospital serving Lindenhurst and the zip code area to the West and North thereof). These patients would be referred/admitted to the proposed Lindenhurst Hospital within two years (sooner) after project completion. In fact, most likely all of them would be admitted to the Lindenhurst Hospital as soon as it opens, through its emergency department.

Furthermore, given the fact that the FEC can only accept basic life support ambulance run patients, and the Emergency Department of Lindenhurst Hospital would be able to accept advanced life support ambulance run patients, the number of admissions to Lindenhurst Hospital from emergency visits would undoubtedly increase.

These patients are truly in need of an area hospital, to avoid long ambulance transports for inpatient care when needed. I have not used these referrals to support any other CON application.
