Dear Ms. Koch:

Per our discussion on December 19th, you stated that Beloit Health System, Inc. is required to report any cancer diagnosis or cancer treatment that occurs at our NorthPointe Health and Wellness Facility located in Roscoe, Illinois. As we discussed, Beloit Health System, Inc. is a Not-for-Profit corporation registered in the State of Wisconsin and also in Illinois as a foreign corporation with the Secretary of State. Further, we have been reporting all diagnosis and treatment of cancer that occurs at our NorthPointe facility to the State of Wisconsin since we opened in December of 2007.

It is my understanding from our discussion that, even though we have been reporting the diagnosis and treatment of cancer to the State of Wisconsin that occurs at our NorthPointe Health and Wellness Facility; we are also required to report this same information to the State of Illinois. When I expressed my concern about dual reporting, you informed me that all States report into an Exchange which eliminates any dual reporting that may occur to the Center of Disease Control and Prevention.

Over the Holidays, I left you a voicemail to call me so that we can connect Diane Lux, who oversees the reporting of our information to the Wisconsin Cancer Registry, with you in order to begin reporting to the State of Illinois beginning in January of this year. I have also provided Diane your telephone number (217/785-7132) and asked her to contact you directly. In the event Diane or I have not been able to speak with you by the time you receive this letter, please contact my office at 608/364-1477 so that we can comply with your request and put the proper procedures in place to ensure future compliance.


