

I would like to express my concern regarding St. Elizabeth's Hospital's application to move its' main campus out of Belleville, Illinois. Although I understand the hospital's need to upgrade its physical facility, I am concerned about the possibility of limiting access to healthcare that may be a result of the move.

In a recent letter to your Board, Kevin Hutchinson, the Executive Director of the St. Clair County Health Department wrote, "We are very concerned that the proposed replacement hospital location will adversely impact the safety net service currently provided by St. Elizabeth's Hospital to residents of St. Clair County." He noted further, "Other hospital emergency rooms in Belleville and Centreville may see a surge in demand and their capacity to meet this need has not been clearly addressed in the application."

There is no doubt that the current hospital in Belleville is in urgent need of a substantial upgrade of its physical facility. I appreciate St. Elizabeth's commitment to invest hundreds of millions of dollars in a new hospital. This investment would create needed construction jobs in our area. Additionally, I have grave concerns for the future of the St. Elizabeth employees. Still, the issue of access to healthcare if the certificate of need were approved remains.

I would urge the Board require St. Elizabeth to consider a new plan that would reinvest these dollars in the current Belleville site. Recently, your Board approved a project that ensured Memorial Hospital in Belleville reinvest and commit to its' Belleville facility while a C.O.N. was granted to build a satellite Memorial Hospital East in the general vicinity of St. Elizabeth's

proposed new facility. This ensured Memorial's commitment to access to healthcare in the Belleville area, while allowing them to expand to other areas of the county. St. Elizabeth's should be required to explore the same option.

Ultimately, the decision on granting or denying St. Elizabeth's proposal lies in the sound discretion of your Board. In reaching your conclusion, I ask that the Board take into account the adverse effect on healthcare access under the current proposal and demand that St. Elizabeth's consider a new plan that would substantially reinvest dollars in its' current Belleville facility.

Dear Ms. Avery,

I am writing in regard to Project #14-043, the St. Elizabeth Hospital move.

First, I would like to share a portion of my involvement with the Greater Belleville community. I am currently on the Board of Directors of: the Belleville Chamber (Past President), the Belle-Scott Committee (Scott Air Force Base Civic group & Past Chairman), the West End Redevelopment Corp. (West Belleville civic group)...past member of the Belleville 201 High School Board (Past President) & Okaw Valley Boy Scouts Executive Committee and many other organizations, too many to mention in the sake of space.

It is my understanding that the purpose of this review board is to ensure that, with the importance of health care as it stands today, all communities are properly served and there are no unsustainable duplication of services. It appears to me that for St. Elizabeth's to build a replacement facility in O'Fallon, within 2 miles of the new Memorial facility, is a perfect example of the exact reason your Board was established. They are not building a satellite like Memorial, they are going to abandon Belleville and their less affluent population for a better payer mix in a much more affluent O'Fallon.

Through presentations I have sat through, Memorial Hospital went through the CON process and painstakingly showed how building a satellite helped the community in Belleville, O'Fallon and surrounding communities by adding services at Memorial East in O'Fallon. The reallocation of beds from the Belleville campus allowed for a conversion of shared rooms to be converted to private rooms, which is what the patient wants. Additionally, the O'Fallon/Shiloh area gets a new facility to augment their growing population. I have to believe that the Board takes into consideration the financial viability of any organization seeking CON approval, because it doesn't serve anybody if the organization can't financially support itself. I also have to believe that if St. Elizabeth's builds a replacement facility within 2 miles of Memorial East, the financial projections of Memorial, that they worked so hard on for CON approval, will become significantly impacted to the point that Memorial East's financial viability would be compromised. Add to that scenario the fact that the downtown Belleville population that so relays on St. Elizabeth's accessibility would ultimately impacted when St. Elizabeth's finally pulls out of Belleville. I sat through the presentation where St.



Elizabeth's presented to the Belleville Chamber Board that they would leave Accounting and Technology offices in Belleville along with an Urgent Care Center, but being a businessman, those decentralized offices won't last long when trying to cut expenses and consolidating offices in one location. Memorial Hospital cannot sustain the added burden of the underinsured. Those two impacts on the Memorial system could spell disaster. Unlike St. Elizabeth's, which is just one part of a 13 hospital system, Memorial is a true Community hospital, building a satellite to increase sustainability and improve service in the challenging healthcare industry. I was just reading about HSHS, St. Elizabeth's parent, in an October 28, 2014 article how their "systemwide revenue increased 4.1% to \$2.09 billion" and how their "total surplus, including investment returns, increased 36% to \$228.3 million." In the same article, the increasing pressure to drop everything to the bottomline is challenging, but there is a lot more room in HSHS to address financial issues than Memorial.

While the impact on Memorial would be significant, the impact to Belleville will be even greater with the significant loss of jobs, real estate off the tax records, not to mention the huge hole left by the footprint of the hospital itself. During her presentation, Maryann Reese indicated that \$20 million was set aside for demolition...why not use that toward modernizing their current facility! Not just Belleville would be impacted, communities south of Belleville would experience longer drive times getting to the O'Fallon facility as well. In my mind, even the O'Fallon community would be negatively impacted with the hospital going where they have the land...my daughter lives in O'Fallon and there are certain times of the day you can't get off the highway without sitting through 5 turns of the street lights. Again, I would mention the underserved in the Belleville community that would not have the ability to get all the way to O'Fallon...the phrase has been used, "abandoning those that need the care the most just to move to a better payer mix." That is the perception and, as we all know, perception is reality.

To sum up, this application is a textbook example of why the IHFSRB was formed in the first place...to prevent the abandonment of one area with great needs and avoid a duplication of services that jeopardize another already approved project. As a businessman, I hesitate to have government get involved in free market decisions, but as this is a non-profit entity, that impacts more than financial shareholders, I must respectfully ask this Board to deny St. Elizabeth's project #14-043.

Dear Ms. Avery:

This letter is being submitted to voice the strenuous opposition of Franklin Neighborhood Community Association (FNCA) to St. Elizabeth's Hospital's plans to close its Belleville hospital. FNCA provides educational and community support to low income families in Belleville, and St. Elizabeth's current site is in the Franklin neighborhood.


Belleville has a large low-income population that will be hurt by the closing of St. Elizabeth's Belleville hospital. The Illinois Department of Education reports that more than 65% of Belleville's students come from a low-income home, and 85% of the students at Franklin Elementary School, which is located less than a half mile for St. Elizabeth's, are living in poverty. I served as principal of Franklin School for five years and know this area very well. Residents of the Franklin neighborhood—many of which do not own cars—can now easily get to St. Elizabeth's. That won't be the case, should the hospital move to O'Fallon.

One of the programs offered through FNCA is a summer camp for children from low-income homes. Understanding the catastrophic consequences of St. Elizabeth's planned move, we surveyed the families of our campers concerning the potential of St. Elizabeth's moving to O'Fallon. This survey process was under the direction of our volunteer and very active FNCA director who also has 30+ years of private sector executive management experience in finance and tax compliance. Twenty-three families responded. Only three of the families (13%) indicated that they would continue to use St. Elizabeth's if it moved to O'Fallon. The remaining 20 families (87%) indicated that they would use Memorial, when in need of a hospital. These are the families living near St. Elizabeth's, and while this is a small sampling of Belleville's low-income families, it strongly contradicts St. Elizabeth's repeated statements that their patients will "follow them."

Stated another way, St. Elizabeth's, by relocating to O'Fallon, will be literally moving from those most in need, and limiting access to Belleville's financially disadvantaged community. Regardless of St. Elizabeth's motives, the impact on Belleville's low-income population would be devastating.

We urge the Illinois Health Facilities and Services Review Board to ensure continued access to care by denying St. Elizabeth's plans.

Esteemed Board Members:

I am writing to you today regarding the relocation of St. Elizabeth's Hospital currently located in Belleville, Illinois. Speaking on behalf of Century Brass Works Incorporated and its related entities; Century Castings Corporation, Metro-East Manufacturing, and Kettler Castings, including over one hundred employees living in the metro area, we oppose the proposed relocation of St. Elizabeth's Hospital to O'Fallon, Illinois.

This move will seriously impact local residents. Many patients have limited resources and are dependent on St. Elizabeth's Hospital to access the medical care they need. Traveling the additional distance to the proposed location would impose unnecessary hardships on their already strained resources. It's not just about the increase in transportation costs, every second counts when trying to save a life.

The residents of Belleville deserve quality medical care and they deserve to be treated in a timely manner. The proposed relocation of the facility to O'Fallon, Illinois would leave local residents with only one option for emergency medical care which could drastically increase wait times for treatment. The increase in the number of patients seeking treatment at the one remaining facility would increase the demand on already overburdened resources during these troubling times.

The proposed move would also negatively impact the city of Belleville and the local business community. Over 1,200 jobs would be leaving the city, causing unnecessary hardships for local businesses that depend on the revenue those jobs generate. A lack of conveniently accessible medical care could also negatively impact property values, causing businesses and homeowners to reconsider moving to the area, which in turn could seriously affect tax revenues for the city. Diminishing tax revenues could lead to a reduction in public services provided by the city for its residents, further depleting existing resources.

There are several alternatives to the proposed relocation. One such possibility is to renovate the current location to upgrade the facility so that it is better prepared to provide new state-of-the-art diagnostics and treatments. A second alternative is to build a new facility in close proximity to the existing facility to continue to provide services to patients living in the area. The effort to abandon low income patients in an attempt to increase revenue by relocating to a more affluent area should not be tolerated.

As a safety professional, I can't in good conscience remain silent when lives are at risk. The medical services provided by the hospital are vital to the wellbeing of our friends and neighbors. It is imperative that St. Elizabeth's Hospital continue to provide medical services for the residents of Belleville, not O'Fallon. We as a community must protect our less fortunate neighbors, and I believe that keeping St. Elizabeth's Hospital in the city of Belleville is imperative.

Thank you for taking the time to hear me. I hope you will carefully consider the impact of your decision on us, our friends and our neighbors.

My wife and I are writing this letter to express our opposition to moving St. Elizabeth's Hospital to O'Fallon, Il.

Previously living twenty miles south of Belleville, my wife and I relied on St. E's for health care. For many towns and villages south of Belleville, St. E's has been relied on as the main hospital for major health issues. I can tell you that on a good day it takes 40 minutes to just get to Belleville from Red Bud.

We all rely on private ambulance services. It should also be noted that not even Belleville has an ambulance or paramedic department. Because of that, the response time can be any imaginable time frame. As mayor of Swansea I am aware of response times. Just recently an ambulance took 20 minutes to get to a local accident scene. The ambulances that serve most of our area and most communities south of Belleville park on parking lots somewhere in the middle of the service area. These ambulances can be as far away as 10 or 15 miles.

Another issue in this area is there aren't always straight routes to Belleville, and if the hospital moves it will create even more problems. St. Elizabeth's is the closest hospital for all those south and east of Belleville. The time to get from the points south or east will cause more chance of death. Imagine living in rural Red Bud or Mascoutah. This isn't like living in St. Louis or Chicago. We don't have 4-lane highways to get from one community to another. The rural roads are old and narrow, and thus do not promote easy access to other areas. St. E's is the closest possible help they can get and could be a life-saver.

Even trying to get to Memorial Hospital from where we live takes 15 minutes on a good day. We only live about 4 miles from Memorial. When you add a response time of anywhere from 15 to 20 minutes and then travel another 15 minutes you just might not survive.

We believe that moving St. Elizabeth's will have a very negative impact on the health of thousands of citizens in this entire area, but especially the rural areas.




I am writing in regard to the pending application (Project #14-043) of St. Elizabeth's Hospital's proposed move to O'Fallon, Illinois.

To whom it may concern,

I am a citizen of the city of Belleville. I live, work, shop, dine, and participate in my community. I am an employee of Memorial hospital. As I did not want my letter to reflect solely on my opinions based on employment at Memorial, my involvement in the city of Belleville is much deeper. My family has roots in this area for over one hundred years. Most of my family members, including myself, were born at St. Elizabeth's hospital.

In the past 3 to 5 years, I have had 4 living grandparents. One of which has recently passed in the month of May. All of these grandparents have had doctors and hospital visits that were at St. Elizabeth's because this was the hospital they've had confidence in for decades. In the recent years their confidence has declined. Some of the things that has changed their opinion about St. Elizabeth's is a lack of concern for patient needs, poor medical equipment, poor recommendations made by doctors, and a lack of respect for families and patients.

I will give you one instance that changed the mindset of one of my grandparents. In August of 2011, she had suffered from a fall just outside her home. She was sent by ambulance to St. Elizabeth's emergency room, per her choice. They found that her arm was broken just below her shoulder, and she was having severe pain and weakness in her groin area and lower extremities. It had been one day since admission to the hospital. My grandmother, who was independent in her home before this without any difficulty, could not walk or even move without severe pain, so much so that she would yell out. We were told that they were going to be discharging her that day, meaning that we would be taking her home in this extreme condition. They had x-rayed her hip, and according to the staff in the emergency room there was a hairline crack in her groin. Therefore we were quite shocked to hear they were sending her home due to Medicare's advice. The Dr. came to give us discharge instructions and was very crass. We asked him about the crack and he acted surprised, saying, "What crack"?

The social worker came and argued that they had no means to keep her if Medicare deems there to be no reason to. We had no time to figure out what to do and felt lost without assistance. We did not know even how we could take care of her on our own, but we knew that something must be wrong for her to be having so much pain and weakness. My family would not typically handle situations this way, but when you are desperate, you have to go through desperate measures. I don't know how to describe it other than to say my mother had to throw a fit to get the staff to listen. We contacted her family physician on our own, and got her to agree to check her out more thoroughly with the threat that we would have to pay the bill if they find nothing. When the x-rays came back it did show she had a hairline crack in her groin area. We were relieved, not because her pelvis was broken, but because we knew what was causing her pain and it could be treated.

We felt betrayed because a hospital should be eager to treat not eager to discharge if there is still a problem. What makes this situation even worse was that the next day my grandmother's oxygen levels dropped to 40 and she almost died. The emergency response team was called and she was saved. I thank St. Elizabeth's for that, but it's scary to think of what would have happened had she been discharged the day before and been at home when that happened. Throughout this situation we felt a constant feeling of defensiveness in replace of concern for the patient.

My reasoning for providing you with this information is not because I think St. Elizabeth's is a bad organization, but I do feel that they are lacking in some major areas. I feel that an organization cannot be fixed by a different location even though Shiloh/O'Fallon is known to be a more wealthy area in the metro-east. The root of the problem must be healed before it can grow. Shouldn't we first raise the bar, make healthcare better, and expect better before we allow an organization to leave a community that needs them?

I do want St. Elizabeth's hospital to stay in my community because we do need them. I agree that expansion may be necessary in the future, but expansion not abandonment. A community that has tried to support and believe in them for decades deserves to be heard. In spite of the problems my family has experienced, I still believe that St. Elizabeth's is a great hospital. They have been known for reaching out to the community in the past. But I am disappointed in them for the lack of remorse for leaving us with seemingly no concern.

Belleville just celebrated their 200th anniversary, and has a large population of elderly. These folks have relied on them because they are close to home, and favor their type of care. We want St. Elizabeth's to stay in Belleville. I hate seeing a community have to beg an organization to stay when it has been a vital part for over a century.

I am writing to express my concerns about the plans for St. Elizabeth's Belleville hospital to relocate from the City of Belleville to the proposed O'Fallon location. I believe this move will adversely impact meeting the health care needs of residents of Belleville, specifically the economically disadvantaged residents. My husband is the Senior Pastor at a large church within blocks of St. Elizabeth's Hospital. Through my involvement with the church I frequently witness the significant needs of residents of the Belleville community, including their health care needs. St. Elizabeth's has stated the new location is only seven miles from the current location, but for many residents of Belleville this will impact their access to care.

Memorial is building a second hospital in Shiloh but this move was based on the needs of that area, not on economic advantages. Memorial Hospital continues to invest in their current Belleville location, over \$168 million in the last 10 years, indicating a commitment to the community needs. If St. Elizabeth's relocates to the O'Fallon community and vacates the Belleville location, it will certainly impact access of care to many Belleville residents, which in my opinion does not support their mission of serving the poor.

In addition, if St. Elizabeth's relocates I am concerned that Memorial's Emergency Department on the Belleville campus would have difficulty managing the additional volume. 
Please accept this letter as an official letter of opposition against the HSHS - St. Elizabeth's Hospital request to build a new hospital in O Fallon IL.

My opposition is based on several factors:

- (1) The proposed site for St. Elizabeth's new hospital in O'Fallon IL is less than 2 miles away from a new full-service hospital that is currently being built and will be open in early 2016 – Memorial Hospital East in Shiloh, IL. To approve another new hospital in O'Fallon/Shiloh Illinois, before Memorial Hospital East is given an opportunity to serve the communities of O'Fallon and Shiloh and become financially viable - goes against healthcare spending prudence.
- (2) At present time, the City of Belleville has approximately 654 licensed acute care beds (338 from St. Elizabeth's Hospital and 316 from Memorial Hospital). In April 2016, those licensed beds in Belleville will be reduced to 554 licensed acute care beds, since 94 licensed beds will go to Memorial Hospital East in Shiloh, IL and 6 beds will go back to the State of Illinois. If the St. Elizabeth CON is approved then in 2017/2018, the number of licensed beds in the City of Belleville will be reduced to 216 licensed beds – for a community that currently has an average daily census of 290 inpatient beds (between Memorial Hospital and St. Elizabeth's Hospital). If St. Elizabeth's Hospital is allowed to leave Belleville, then **access to care will become a hardship** for the underserved population in Belleville (with limited transportation) and its surrounding communities (in particular the communities south of Belleville).
- (3) The St. Elizabeth Hospital building (built in 1954) is only 4 years older than the Memorial Hospital building (built in 1958). Should the CON process reward an organization for not investing in its physical plant by allowing them to abandon their community when their asset (hospital building) becomes aged? Fiscal neglect and lack of long-term planning should not be rewarded.
- (4) Downtown Belleville does have enough available land and a willing partner, the Belleville City government, to build a new St. Elizabeth's hospital building in downtown Belleville, which would allow both current hospitals in Belleville to continue serving its underserved and underinsured population in Belleville and the communities south of Belleville.

Members of the Review Board:

As residents of Belleville, we are encouraging the Board to deny St. Elizabeth's Hospital's CON to move from Belleville to O'Fallon. While numerous reasons have been voiced to discourage the move including (1) duplication of services in O'Fallon with the soon to be opened Memorial Hospital only two miles away, (2) the negative economic effect to the renewed vitality of the core of new Belleville businesses with the moving of approximately 1,200 jobs out of the City; and, the loss of Belleville homeowner's property value as well as degradation of the planned and potential growth of the City; and, (3) the most important negative effect will be to the patients who rely on St. Elizabeth's Hospital.

In the past twenty years, the area to the south and southwest of Belleville has experienced a significant growth. Smithton, Freeburg, Millstadt, New Athens, Waterloo, Columbia and the areas surrounding those towns have grown exponentially. One only needs to look at the significant increases in the enrollment in the grade schools and high schools which serve these communities to realize that these areas are having significant growth and will continue to have significant increases in population---people to whom St. Elizabeth's needs to provide health care. A proposed highway coupler from Troy, to Mid-America Airport (crossing I64), the south side of Belleville, the south side of Millstadt, to Columbia and Route 3/I255 will eventually be built. This will cause further increases in population along that corridor, especially south and southwest of Belleville. From a community planning perspective and providing "critical health care services" within a thirty (30) to sixty (60) minute period of time for these residents and most of the residents of the City of Belleville and adjacent population areas (Belleville, Swansea, etc. zip codes) as well as Centreville, East

St. Louis, Cahokia, Dupo, it appears that a "new metro Belleville" St. Elizabeth's Hospital should be physically close to a proposed intersection of the planned coupler and Illinois 15 (which would also make it accessible to the Interstate System) and remain part of the City of Belleville. If, as St. Elizabeth's management contends, it wants to be a "regional hospital" and on or near an Interstate, this site could provide a venue for such a venture and allow it to "partner" with community hospitals to the south of Belleville and become a part of the SIU Medical School as a teaching hospital (to provide more Doctors to serve the rural areas). Such a facility could continue to use the offices at the present St. Elizabeth's campus, since geographically it would be nearby. The planned move to O'Fallon seems to be based on the perceived notion that only that area will grow in the future (along the I64 corridor). One hopes and believes that a venture ("new metro Belleville" St. Elizabeth's Hospital) as this, would have the support of the City of Belleville, Memorial Hospital, and; also, St. Clair County officials since Belleville is a significant economic force to the County. I have been a Belleville resident for 27 years; however, I was born and raised in Springfield, IL. It is a city where they have two very successful hospitals that work together to serve that community. They are located only blocks from one another and neither felt the need to move to a more affluent location. St John's Hospital, a sister hospital to St. Elizabeth's has been able to stay in the same location and add on as it has grown over the past 140 years. They did not cry out that their building was too old, they maintained it, and added onto their current location as they grew.

If St. Elizabeth's Hospital Board of Directors and its leaders would have managed the building and the grounds appropriately, they would not be using this as an excuse at this time. I do not believe that a community should suffer because of poor management. Belleville Memorial could not take on the influx of patients that would occur if St. Elizabeth's closed. 



Why has St. Elizabeth failed to keep up with renovations to their current facility? MaryAnn Reese, CEO of St. Elizabeth's, said at one of the forums that the sisters needed to "pray for the boiler." Shouldn't we really be praying for the patients who are currently being "served" in a building that hasn't had its boiler replaced in over 60 years?
