Notice of an Opportunity for an Administrative Hearing



The request must be postmarked no later than 30 days after the delivery of this Notice. Failure to request a hearing in the manner and within the timeline described will result in a waiver of your right to a hearing.

If you decide to exercise your right to a hearing, the hearing will be conducted in accordance with Section 10 of the Act and Part 1130 of Title 77 of the Administrative Code [77 Ill. Adm. Code 1130]. The State Board shall appoint a hearing officer within 30 days after receiving your request. The hearing officer will afford you the opportunity to demonstrate that your application is consistent with the review criteria. After the hearing officer submits its report and recommendation to the State Board, or upon default of the party to the hearing, the State Board shall make its final determination.
