Dear Ms. Avery and Constantino:

As you know, we are counsel to Silver Cross Ambulatory Surgery Center LLC ("SCASC") and Silver Cross Hospital and Medical Centers ("Silver Cross Hospital," and collectively with SCASC, the "Applicants"). Pursuant to 77 Ill. Admin. Code § 1130.650, the Applicants hereby seek to modify the Application for Permit (the "Application") filed by the Applicants to establish a multi-specialty ambulatory surgical treatment center (the "Surgery Center") on the Silver Cross Hospital campus, near the southwest corner of Route 6 and Silver Cross Boulevard in New Lenox, Illinois, in order to reduce the high utilization and projected demand for outpatient surgical services at Silver Cross Hospital.

Specifically, the Applicants would like to add gastroenterology ("GI"), pain management, and otolaryngology ("ENT") to the types of surgeries that can be performed at the Surgery Center. This modification constitutes a "Type B" modification because adding additional surgical specialties to a proposed multi-specialty surgery center does not constitute a "Type A" modification. It should be noted that these additional surgical specialties will not add to the number of operating rooms at the Surgery Center, will not add to the cost of the Surgery Center, and will not add to the size of the Surgery Center. Indeed, these additional surgical specialties will not negatively impact the Application in any manner and are only being added to comply with the recent changes to 77 Il. Admin. Code § 1110.1535.

In support of these additional surgical specialties, the Applicants have obtained attestation letters from physicians on the active Medical Staff at Silver Cross Hospital, copies of which are attached hereto as Exhibit A and summarized below. Please note that the attestation letters have been limited to patients located in Silver Cross Hospital's primary service area, defined by the following zip codes: 60403, 60421, 60423, 60432, 60433, 60435, 60436, 60439, 60441, 60442, 60448, 60451, 60467, and 60491.
