Dear Mr. Constantino:

I am writing on behalf of DaVita Inc. ("DaVita") to notify the Illinois Health Facilities and Services Review Board (the "Board") of the change of DaVita's legal name from DaVita Healthcare Partners Inc. to DaVita Inc., effective September 1, 2016. Importantly, there has been no change of ownership or control of DaVita, but only a change of the entity's legal name. To document there was no change of ownership, we have enclosed the prior and current Certificates of Good Standing. As you can see, the corporate file number assigned by the Secretary of State and the date of incorporation which are associated with the entity have not changed.
