Dear Ms. Avery,

As indicated in our April 10, 2020 Annual Progress Report submission, the approve project is progressing diligently. However, we are monitoring the construction schedule closely to evaluate whether or not there might be a minor delay in completing construction due to COVID-19 influences. At this point, we do not anticipate any impact to our completion date, but will keep the State Agency informed.

On another matter, we are finalizing the design for the next construction phase. In doing so, there is a minor change in sq. ft. allocation between the oncology infusion functional area and Rural Health Clinic. The change is identified on Exhibit A, attached, which is integral to this notification letter; it indicates an addition of 86 sq. ft. to the Oncology Infusion area with a corresponding reduction of 86 sq. ft. to the Rural Health Clinic space allocation. As noted on the exhibit, there is no change in project scope nor capitalized project cost (per notes on Exhibit A)

Notes:

- 1) There is no change proposed in total square feet due to the revised design for the Rural Health Clinic and Oncology Infusion Area
- 2) Eighty-six (86) additional sq. ft. is allocated to the Oncology Infusion functional space / Department based on the design.
- 3) Similarly, the Rural Health Clinic is reduced by 86 sq. ft.
- 4) The Rural Health Clinic space allocation includes space for an oncology physician.
- 5) There is no change in CON approved services due to this space distribution which is based on a detailed design subsequent to permit approval.
- 6) There is no change in approved capitalized project cost due to this refined design.
