In accordance with the requirements of the Illinois Health Facilities Planning Act, Notice is given of a modification of an application for permit for a proposed construction and/or modification project (Project #18-002) from Retina Surgery Center. The applicant proposes to establish a limited-specialty ASTC offering Ophthalmologic surgical services, in 4,919 of leased space, located at 8780 West Golf Road, Suite 102, Niles. The estimated project cost is \$2,247,076.

The application is considered a Type A Modification and was modified on May 14, 2018. The modification consists of an increase in the cost of the project from \$2,247,076 to \$3,132,496 or \$885,420.
