1. The Transaction

The Applicants (Center for Health Ambulatory Surgery Center, LLC, OSF Healthcare System, d/b/a OSF Saint Francis Medical Center, Peoria and Musculoskeletal Surgery Center, LLC.) propose the sale of the assets of Musculoskeletal Surgery Center, LLC d/b/a Great Plains, LLC for \$3,950,000. Musculoskeletal Surgery Center is a limited specialty ambulatory surgical treatment center performing orthopedic procedures only. The transaction is an asset purchase of a health care facility resulting in a change of the current licensee. The licensee will be Center for Health Ambulatory Surgery Center, LLC and the owner of the site is Cullinen Kumpf Medical, LLC. The expected completion date is May 1, 2018.

Center for Health Ambulatory Surgery Center, LLC is purchasing the assets of Musculoskeletal Surgery Center, LLC d/b/a Great Plains, LLC for \$3,950,000. OSF Healthcare System, d/b/a OSF Saint Francis Medical Center, Peoria currently owns 71.4% of Center for Health Ambulatory Surgery Center, LLC and individual physicians own 28.6%. At the conclusion of the transaction OSF Healthcare System, d/b/a OSF Saint Francis Medical Center, Peoria will own 61.4% of the Center for Health Ambulatory Surgery Center, LLC, and individual physicians will own 28.6% and 10% by Musculoskeletal Surgery Center, LLC. No changes in services are expected for 24 months following the completion of the change of ownership,

2. Public Hearing

No public hearing was requested and no support or opposition letters were received.

3. Criterion 1130.500, Criterion 1130.525, Criterion 1130.560 - Application for permit or exemption; exemption regulations.
