RE: Change of Ownership Exemption, Health Facilities Planning Act--Part 1130 Exemption.  
Exemption #: E-008-21, Greater Peoria Specialty Hospital  
Exemption Holder: OSF Healthcare System, Greater Peoria Specialty Hospital, LLC, Kindred Healthcare, LLC.

Gentlemen:

On August 16, 2021 the Chairwoman of the Illinois Health Facilities and Services Review Board (State Board) acting on behalf of the State Board approved your request for a change of ownership exemption referenced above. The approval was based upon the application's compliance with applicable provisions of 77 ILAC Part 1130. The exemption is for a change of ownership of a hospital. The entity to be licensed is Greater Peoria Specialty Hospital, LLC. The hospital has the following categories of service and beds:

<u>Categories of Service</u>	<u>Beds</u>
Long Term Acute Care	<u>50</u>
Total	<b>50</b>

To demonstrate completion of this transaction, the exemption holder shall provide written notice and related documentation to the State Board of the following: for changes of ownership in which the applicant submitted key terms of the transaction, certification that the transaction was or was not completed according to the key terms contained in the application. The exemption holder must submit the certification within 90 days after the closing date of the transaction; and for changes of ownership in which the applicant submitted the final transaction documents, notice of project completion, no later 90 days after the change of ownership. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable prior to acquisition. The exemption will be invalid should the facility for which the change of ownership was granted cease to be an existing health care facility as defined in 77 IAC 1130.140.
