Please be advised that, effective as of the date of this letter, Touchette Regional Hospital is suspending admissions to its obstetrics category of service, as a result of absence of pediatricians to attend to newborns and delays currently being experienced with the Certificate of Exemption ("COE") process. A COE application addressing the discontinuation of the category of service was filed on February 18, 2020; and the scheduling of a Public Hearing on the application is being delayed due to the ongoing pandemic crisis.

You will be notified of the status of the service on a monthly basis.


Dear Ms. Avery,

The above-referenced Permit was issued by the HFSRB on May 8, 2019, and addresses the addition of twenty (20) beds to an existing two hundred and forty-two (242) bed rehabilitation hospital in shell space for a total of two hundred and sixty-two (262) rehabilitation beds in Chicago, Illinois.

The scope of the project has remained generally consistent with that provided in the CON application, and the project continues to be funded by cash, as proposed in the CON application.

To date, approximately Seven Million, Five Hundred Fifty Thousand (\$7,550,000) Dollars has been spent on the project, suggesting that the project is approximately 64% complete. The primary project components that have been completed include: 25th floor AbilityLab Renovation and twelve (12) patient rooms on the 25th floor. Still to be completed are the eight (8) patient rooms on the 20th floor.
