

Dear Chairwoman Olson:

I am writing to express my strong support for SwedishAmerican Health System's proposed modernization of its existing facilities and services, and its construction of a new Women's and Children's Center on the existing hospital campus. This project will benefit the entire city of Rockford, and will be especially important to the Rockford west and south side communities that have been directly served by this vital hospital for over 100 years.

The proposed \$130 million modernization and expansion will include private inpatient rooms, as well as a modernized Emergency Department, operating rooms, and other needed services.

Importantly, SwedishAmerican plans to establish a state-of-the-art Women's and Children's Center that will include a Neo-natal Intensive Care Unit (NICU). Once approved, the NICU would allow SwedishAmerican to apply for designation as a Level III Nursery and treat more complex neo-natal patients – making such care immediately accessible to the west and south sides of Rockford. SwedishAmerican is already the largest birthing center in Rockford, and is the only area hospital to have received the Healthgrades' Labor and Delivery Excellence Award. The addition of a Level III Nursery at SwedishAmerican, together with the new Women's and Children's Center, will assure access to the highest quality of care for all Rockford area families.

I enthusiastically support the SwedishAmerican proposal to modernize its facilities and create a new Women's and Children's Center.
