Julie Goebel called me back and confirmed the total number of authorized beds in medical surgical is not changing. It is just that the rooms where the LTC unit was are being re-allocated to existing med surgical beds. Apparently some of the MS beds on the 4<sup>th</sup> and 5<sup>th</sup> floors are being moved up to the 11<sup>th</sup> floor where the LTC unit was located. It will result in more private rooms and a better configuration of space to certain services. I've copied Julie Goebel who provided me with this information.
