## Board Members:

We are asking the Board Chair to approve three (3) change of ownerships of Illinois licensed ASTCs. The three ASTCs are all part of the same transaction.

Envision Health Care Holdings Inc and AmSurg Corp. are publically traded corporations that are merging in an all stock transaction.

AmSurg Corp owns a controlling interest (51%) in three (3) ambulatory surgical treatment healthcare facilities in Illinois:

- 1) The Lake Bluff IL Endoscopy ASC, LLC, d/b/a North Shore Endoscopy Center, in Lake Bluff, Illinois (#E-022-16)
- 2) Oak Lawn IL Endoscopy ASC, LLC, d/b/a Oak Lawn Endoscopy Center, in Oak Lawn Illinois (#E-023-16) and
- 3) Glen Endoscopy Center, LLC, in Glenview, Illinois (#E-024-16).

Envision and AmSurg Corp. are merging with Envision as the remaining controlling entity. This transaction is considered a change of ownership requiring approval of the Chair because ultimate control of the licensed health care entity is changing.

There was no public hearing no opposition and the applicants have provided all of the required information.
