

We have attached two change of ownership exemption applications for your review.

**#E-025-16 – Midwest Center for Day Surgery, LLC**

We are asking the Board Chair to approve a change of ownership of Midwest Center for Day Surgery, LLC a multi-specialty ASTC located at 3811 Highland Avenue, in Downers Grove. The facility is currently owned by multiple physician owners (51 %) and Evangelical Services Corp, a subsidiary of Advocate Health Care Network (49%). Under the proposed transaction, Advocate-SCA Partners, LLC would acquire, fifty-one percent (51 %) of the ownership interest in Midwest Center for Day Surgery, LLC. Following the transaction, the Physician Owners will own forty-nine percent (49%) of Midwest Center for Day Surgery, LLC, and Advocate-SCA Partners, LLC will own a fifty-one percent (51 %) interest. The transaction is considered a stock transaction resulting in no change in the current licensee. There was no request for a

public hearing. No opposition comments were submitted and the applicants provided all of the necessary information.

## #E-026-16 – Castle Surgicenter, LLC

We are asking the Board Chair to approve a change of ownership of Castle Surgicenter, LLC a multi specialty ASTC located at 2111 Ogden Avenue, Aurora, Illinois. Rush-Copley Surgicenter, LLC, proposes to purchase the assets of Castle Surgicenter, LLC. The new licensee will be Rush-Copley Surgicenter, LLC, d/b/a Rush-Copley Surgicenter. Rush-Copley Surgicenter, LLC, is a newly created limited liability corporation that is a subsidiary of Copley Memorial Hospital, Inc. Copley Memorial Hospital is the sole member of Rush-Copley Surgicenter, LLC. There was no request for a public hearing. No opposition comments were submitted and the applicants provided all of the necessary information.
