Board Members:

The State Board Staff is asking the Board Chair, acting on your behalf to approve a change of ownership of a health care facility. The Applicants (Iowa Health System d/b/a UnityPoint Health and Memorial Hospital Association) propose a change of ownership of a health care facility Memorial Hospital Association (Memorial Hospital), 1454 North County Road, Carthage, Illinois (#E-026-18). Memorial Hospital is an 18-bed critical access hospital. This change of ownership constitutes a change in control of a licensed health care facility.

The Applicants propose that Iowa Health System d/b/a UnityPoint Health become the sole corporate member of Memorial Hospital Association. The transaction will result in a change in the membership or sponsorship of a not-for-profit corporation that owns or controls a licensed health

care facility. There will be no change in the licensee or ownership of the site. The fair market value of Memorial Hospital is \$17,366,016. The Applicants attest that the health care facility will not adopt a more restrictive charity care policy in effect one year prior to the transaction and will maintain compliance with the charity care policy for a minimum of two years following the change of ownership transaction. All attestations required by the State Board have been provided as required.

All of the information required by the State Board was provided. No letters of support or opposition were received and no public hearing was requested.
