I am writing in response to the false and irresponsible accusations of Mercy Health in its lawyer's letter to you dated September 15, 2017 asserting that Centegra Hospital – Woodstock improperly discontinued services without Review Board approval and also goading the Review Board to initiate what would constitute a completely frivolous compliance action against Centegra.

Centegra Hospital – Woodstock has not discontinued services without Review Board approval. Centegra has, in full compliance with the Review Board's rules, temporarily suspended designated services at Centegra Hospital – Woodstock, as acknowledged by Review Board Chairlady Olson in her attached letter to Centegra dated August 18, 2017, and further, again in full compliance with the Review Board's rules, Centegra has submitted an exemption application to the Review Board to permanently discontinue the designated services at Centegra Hospital – Woodstock. Mercy Health and its lawyer knew this at the time they made their false accusations.

On behalf of Centegra Health System, I respectfully request that the Review Board and its staff take appropriate action to assure that Centegra's pending applications before the Review Board are not prejudiced by Mercy Health's false accusations, including but not limited to the removal of those letters from the project files.
