On August 26, 2020, the Chairman of the Illinois Health Facilities and Services Review Board (State Board) acting on behalf of the State Board under 77 IAC 1130 (Part 1130) approved your request for a change of ownership of Memorial Hospital – East, 1404 Cross Street, Shiloh, Illinois. The approval was based upon the application's compliance with applicable provisions of Part 1130. The Exemption Holders were approved for a change in the licensee of Memorial Hospital-East, 1404 Cross Street, Shiloh, Illinois. The new licensee is Protestant Memorial Medical Center Inc. d/b/a Memorial Hospital-East and the owner of the site is Protestant Memorial Medical Center Inc.

You are reminded that a final report must be submitted to the State Board no later than 90 days following the anticipated project completion date. You are also reminded that failure to complete the project within the 24 months after the Board approved the exemption will invalidate the exemption. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable to this transaction.
