HEARING OFFICER MORADO: Time for the hearing to start. Good afternoon. I'm still Juan Morado, Hearing Officer for the Illinois Health Facilities and Services Review Board. Present with me today is Board Chairwoman Kathy Olson and assistant general counsel Jeannie Mitchell.

On behalf of the Health Facilities and Services Review Board, thank you for attending this public hearing for Kishwaukee Community Hospital, or -- excuse me, for Valley West Community Hospital. As per the Rules of the Illinois Health Facilities and Services Review Board, please note that the previously published legal notice is entered as today's public record and has been given to the court reporter.

As previously stated, this public hearing is conducted by the staff of the Illinois Health Facilities and Services Review Board pursuant to the Illinois Health Facilities Planning Act, and affords an opportunity for parties with interest in the project to present a written and/or verbal comments pursuant to the project. All allegations or assertions should be relevant to the need for the proposed project and be supported with two copies of

1 documentation or materials that are printed or typed
2 on paper, 8 1/2 by 11.

3 Please note that in order to ensure that the
4 Health Facility and Services Review Board's public
5 hearings protect the privacy and maintain
6 confidentiality of an individual's health information,
7 covered entities as defined by the Health Insurance
8 Portability and Accountability Act of 1996, such as
9 hospital providers, health plans, and health care
10 clearinghouses, submitting oral or written testimony
11 that discloses protected health information of
12 individuals shall have written authorization from this
13 individual. The authorization shall allow the covered
14 entity to share individual health information at this
15 hearing.

1 numerical order. Prior to beginning your remarks,
2 please clearly state and spell your whole name. After
3 you have concluded your remarks, please provide those
4 copies to us up here as well as your completed sign-in
5 sheet. Thank you.

6 Today's proceedings, we are going to begin
7 with a representative from KishHealth. I have several
8 forms here. We already have the comments that have
9 been turned in and will be entered into the record.
10 The first individual to speak would have been T-o-m,
11 M-a-t-y-a, from KishHealth System, and we have his
12 written comments.

13 The next person would have been Northwestern
14 Medicine's Mike Viboda, that's V-i-v-o-d-a, and we
15 also have those written comments that will be read
16 into the record.

17 Next we have KishHealth System's Kevin
18 Poorten, and we have those written comments which will
19 be entered into the record.

20 Next would be Michael Flora of the Ben
21 Gordon Center, who also submitted written comments
22 which will be read into the record.

23 And next we have KishHealth System's Michael
24 Kulisz, who submitted written comments which will be

1 entered into the record.

2 Next we have Mr. Barry Schrader. Mr.
3 Schrader, please approach the podium.

4 MR. SCHRADER: Barry, B-a-r-r-y,
5 S-c-h-r-a-d-e-r, DeKalb, Illinois. I'm affiliated
6 with an ad hoc group called the DeKalb County Citizens
7 for the Betterment of Health Care. Anyone here from
8 Sandwich? Okay. I guess I won't be able -- I am not
9 asking but if they mention something specifically, I
10 have similar concerns for Sandwich Hospital. In fact,
11 different concerns, because they are a much smaller
12 hospital and they have not been with the Health System
13 as long as Kishwaukee Hospital and medical staff.

14 As some people know, the DeKalb clinic was
15 purchased earlier this year by KishHealth System, and
16 they eliminated all of the seniority of all the staff
17 so they have to start over from zero. Sandwich
18 Hospital, of course, doesn't know -- I'm sure no one
19 has told them as far as whether their staff will be
20 affected by the same action, whether Northwestern
21 takes over, if they will lose all of their seniority
22 and years of services.

23 I also see that the application states that
24 Northwestern and KishHealth have agreed to keep the

1 hospital and the level of services at the same level
2 for 24 months. I guess that means that all bets are
3 off after two years as to whether they will continue
4 to operate the hospital as it's operated now, or
5 whether they will continue to keep the services there
6 and move services elsewhere.

7 All those are questions that I think
8 citizens of Sandwich would care about. Since the
9 Kishwaukee Health System's Board of Directors will be
10 dissolved, and they will be allowed to nominate five
11 of those members to send to the bigger, western
12 regional board of Northwestern, how many are there
13 from Sandwich area? Is anyone from the Sandwich area,
14 the Sandwich Hospital people, I am talking about
15 geographically, from the Sandwich area?

16 That's just some of the concerns. My health
17 care -- I mean, my new mental health questions were
18 answered in some respects by the testimony this
19 morning, but the problem is they are giving us the
20 same answers they did six years ago. They can strap
21 someone in an ambulance to send them to another
22 hospital in another county and take an hour's drive,
23 leaving the family, the doctors that treated this
24 patient or this client here and the health care

1 providers, including their therapists and counselors,
2 with a long distance to travel, and they don't have
3 the same residency -- what should I say -- they don't
4 have the same license, I guess you would say, to treat
5 the patient in this far off psychiatric hospital in
6 DuPage County. So that has been changed over six
7 years and those answers to me were not satisfactory,
8 and I hope other people can share those.

9 The only other thing I was going to suggest
10 is that the Sandwich Hospital is much closer to Kane
11 County and to Kendall and some of the other areas. So
12 they may have options where they can send their
13 patients who need psychiatric help who are admitted to
14 the emergency room. Will they be allowed to do that?
15 Or since DuPage is owned by Northwestern Health all of
16 their patients will be allowed -- we are talking about
17 inpatient care for mental health services -- will all
18 of them be required to travel, be sent by ambulance to
19 DuPage, only with no choice by the family or the
20 patient as to where they are treated?

21 Thank you very much for holding the public
22 hearing in DeKalb County, because it makes a big
23 difference to us not to have to travel down to
24 Springfield. And I look forward to seeing you again

1 in Bolingbrook. Thank you.
