On September 13, 2021 at 11:00AM, Chairman Michael J. Brennan called the meeting to order. Without a quorum present, Chairman Brennan began the meeting with announcements. The Chairman congratulated Commissioner Flores on her appointment as an Associate Judge of Cook County. The Chairman updated the Board that the office move has been completed. The Chairman also stated that CompFile paperless system is entering Phase 4 to include the SIF, RAF and SI divisions of the office and special permission was granted to renew the services of Microsoft. Chairman Brennan announced that the Commission is reinstating the enforcement of the Red Line Cases, meaning that if a case is 3 years old or older the Petitioner or Respondent must state in writing why it must be continued. CompFile now has the capability to complete this.

The Chairman added that retired Judge McGing was asked to serve as an independent arbitrator and inquired if the Board Members knew of anyone else who would be available for this position. Independent Arbitrators hear workers' compensation cases for employees of the IWCC.
