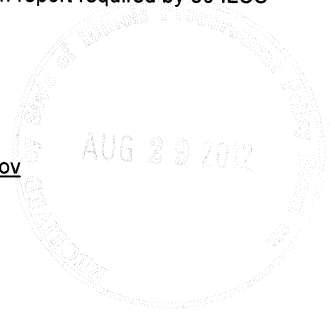

Status call regarding the PPA and the procurement plan: Mr. Champagne advised that the Alliance had not received much feedback on the draft sourcing agreement. He advised that the Alliance had scheduled a meeting with Levitan in Pittsburgh on Aug. 7th. He also advised that the Alliance was in the process of scheduling meetings with new ICC Commissioner McCabe and ICC staff to provide an update on the status of the FutureGen 2.0 project. Director Juracek stated that the IPA planned on including a discussion of FutureGen 2.0 in the draft 2013 power procurement plan. She stated that she would use the powerpoint presentation delivered at the March 6th ICC public policy meeting for background. She advised that the IPA would include the proposed sourcing agreement as an attachment to the draft plan. Director Juracek described the benchmark setting process and advised that Levitan had been retained to develop the benchmarks for the FutureGen 2.0 project.
