On 11/30 ComEd confirmed delivery of RECs for a 2012-2013 Annual RFP supply contract from a hydroelectric plant in Marinette County Wisconsin. Eileen Maroney of ComEd called Michael Strong of the IPA to inquire about the renewable energy facility Wisconsin and whether it could be designated as eligible for IL-RPS in the PJM EIS system. Michael responded that he would pass the request to Arlene Juracek. Arlene Juracek responded by IPA COMM FORM V1 120216

with a phone call on 12/3 to confirm details of the request and initiated a request to PJM EIS personnel to add this designation to the hydroelectric plant in the PJM EIS system and cc'd ComEd. On 12/4, Arlene Juracek sent a subsequent email to Eileen Maroney to confirm the completion of the change in the PJM EIS system.


