Presentation by Mitzi Woodson on the proposed TPM rule changes:

The proposed rule changes for Training Program Manager are:

Changing required course hours from 40 to 24

Changing experience requirement from five years' experience as a fire service Instructor II and/or training officer to three years documented cumulative experience beginning from Fire Service Instructor II certification date.

By expediting the process, DPSE will be able to include these changes with the submission of the regular proposed rule changes. If not, these rule changes will need to be submitted for approximately years. In addition, by expediting the SCAC process, the Office will be able to schedule pilot course(s). The pilot courses will include required training for DPSE staff members.
