Legislative Update Katherine Nunes

- We are looking out for valet trash or flammable refrigerant bills that may make their way into the legislature. If see one, please let me know.
- Hb640 – Adds 2 members to the FAC – one for IAAI and MABAS.
- Hb691 – It extends the sunset date on licensing for those working on underground storage tanks.
- Hb798 – It supports enforcement by OSFM, provides for individual licensing of those inspecting and testing sprinkler systems, requires registration of each sprinkler system, develops a limited contractor license related to pump work, and provides for consistency and housekeeping. Please let me know if want to be involved in further stakeholder discussions.
- HB2898 is a fireworks bill moving into committee next week. It is treating something that is a consumer firework as if it is not a consumer firework.

Minimum Firefighter Training Guide Jim Keiken

The 2021 Minimum Firefighter Training Guide has been updated to fall more in line with the NFPA standards. Three (3) more topics have been added to the original four (4) that are contained in the current Training Guide. The three (3) new topics are

- Apparatus Officer
- Fire Officer/Incident Command
- Training Officer
