

Revised Narrative Statement

McHenry County Emergency Telephone System Board

The County of McHenry established an Emergency Telephone System Board (ETSB), as authorized by Illinois Statute for the purpose of establishing and maintaining an Emergency Telephone Number System, for the citizens of McHenry County.

The original narrative statement submitted in 1991, and approved by Order of the Commission on March 31, 1992, indicated nine (9) Public Safety Answering Points (PSAPs) in McHenry County, and was issued docket number 91-0558. October of 2005, modification 05-0699 was approved reducing the number of PSAPs to seven (7). And, in March of 2011, modification 11-0267 was approved reducing the number of PSAPs to six (6).

Pursuant to Public Act 99-006, (50 ILCS 750/15.4(a)(3)), a county with a population of at least 250,000 and a single Emergency Telephone System Board shall reduce the number of PSAPs by at least 50% or to two, whichever is greater. January 21, 2016, the McHenry County ETSB voted unanimously to close the following three (3) PSAPs on, or before, June 30, 2017

The three (3) remaining PSAPs, indicated below, will continue to provide back-up services for 9-1-1 calls routed by at&t's selective routers, as they are currently configured.

McHenry County Sheriff's Department is backed up by SEECOM, and both SEECOM and McHenry PD are backed up by McHenry County Sheriff's Department. Calls for service will be relayed, or dispatched, dependent upon the level of failure. All the same enhanced features (ANI/ALI) will be provided at the back-up PSAP for these calls.

Tentatively, the following agencies will be contracting for dispatch services with, and 9-1-1 calls will be routed to, McHenry Police Department.

1. Harvard Fire Department
2. Harvard Police Department
3. Marengo Police Department
4. Union Police Department
5. Woodstock Fire Department
6. Woodstock Police Department

Tentatively, the following agencies will be contracting for dispatch services with, and 9-1-1 calls will be routed to, SEECOM.

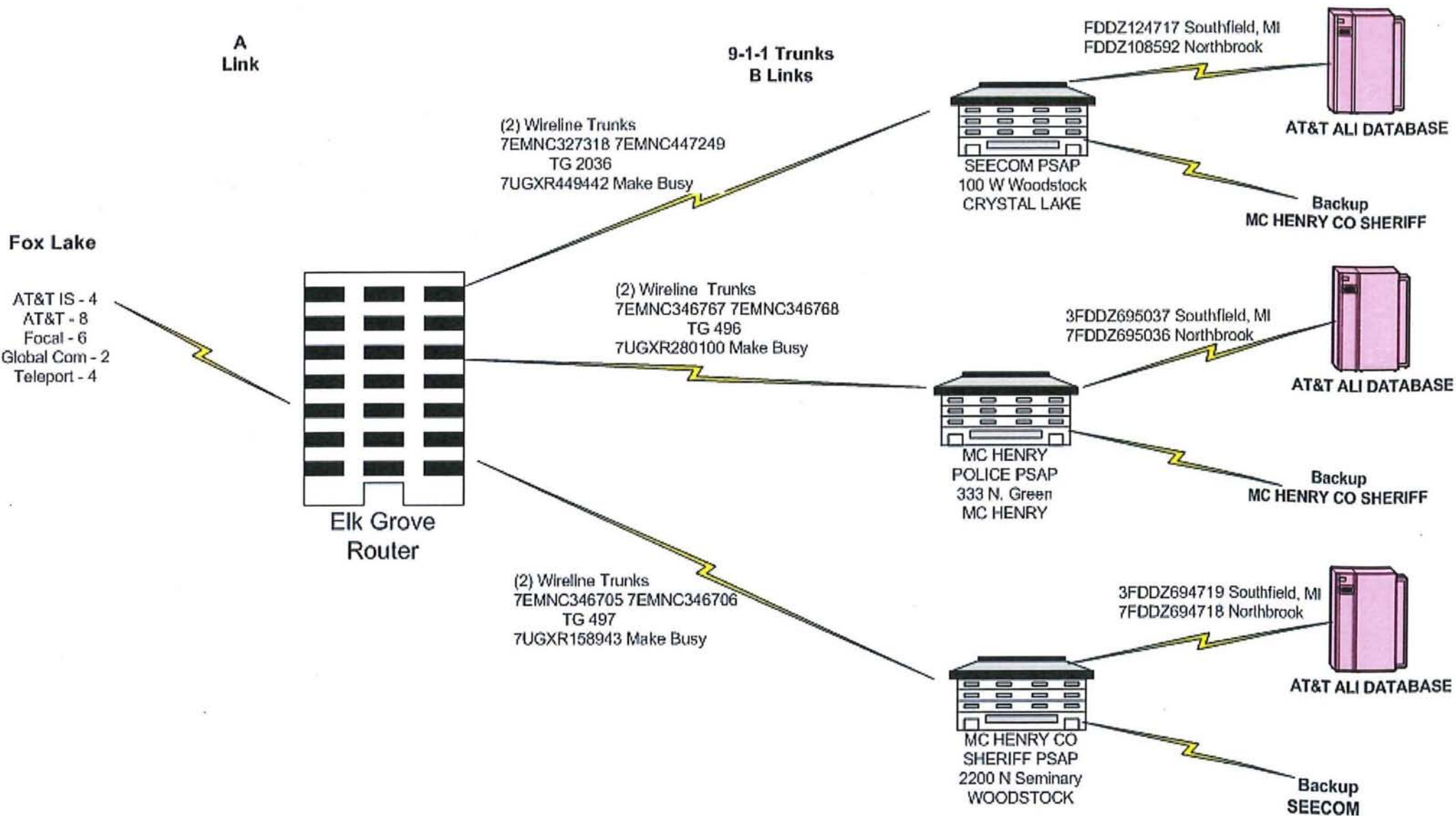
1. Fox River Grove Police Department
2. Huntley Police Department
3. Lake In the Hills Police Department

Separate from the consolidation, McCullom Lake Police Department has contracted with McHenry County Sheriff's Department for dispatch services. 9-1-1 calls will continue to be routed to McHenry Police Department.

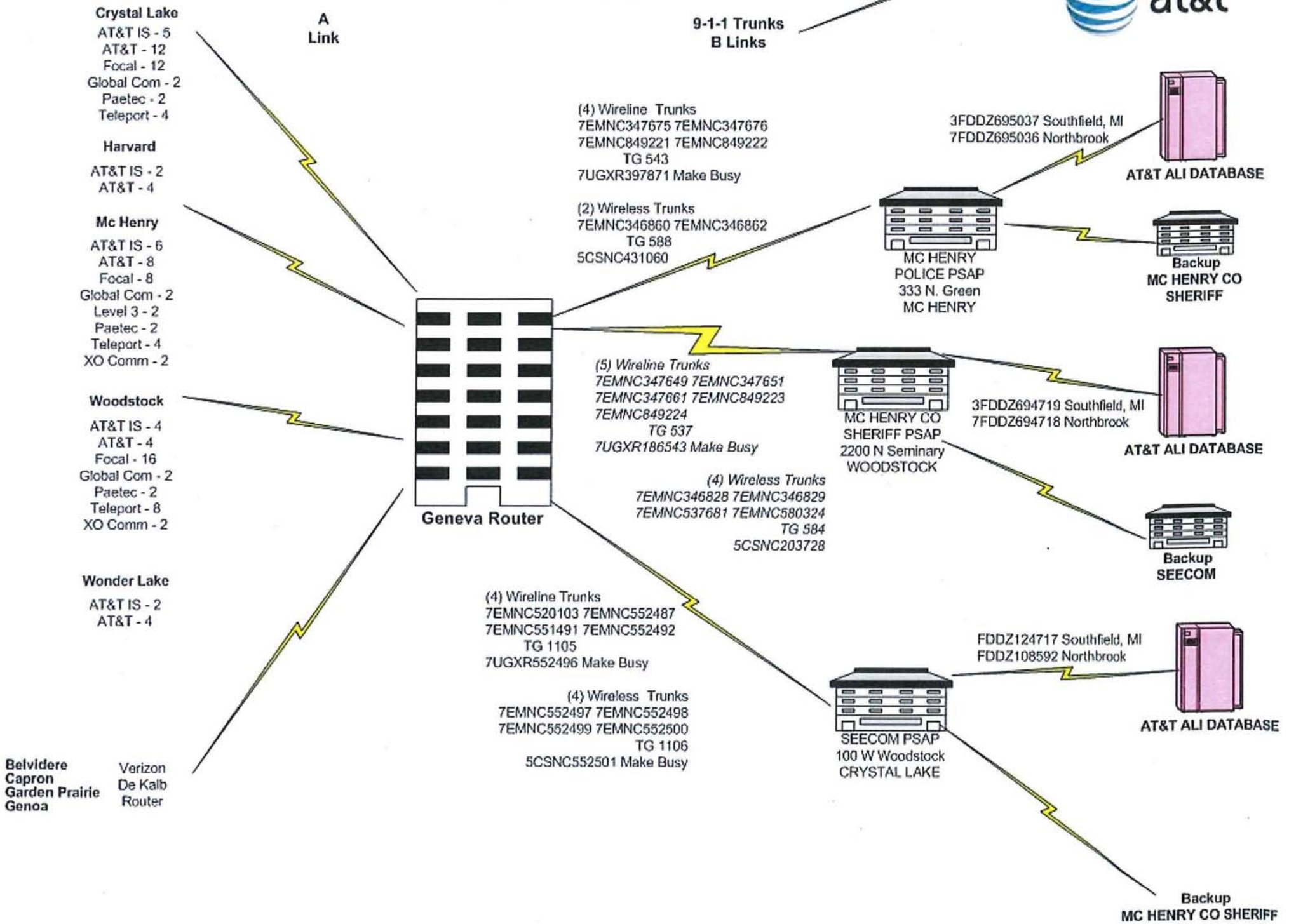
The following ESN's, in the at&t Selective Routers, will be provisioned to the answering points as indicated below. Calls will be routed on or before June 30, 2017.
